Following the parliamentary elections in Slovenia, the term of office of one of the members of the Slovenian delegation to the Committee of the Regions, Ms Barbara Žgajner Tavš, has expired at the local level. Consequently, she no longer remains eligible as a member of the Slovenian delegation to the Committee of the Regions.

According to the Decision of the Government of the Republic of Slovenia on criteria and procedure for the composition of delegations of representative associations of municipalities in international organisations of municipalities and other international organisations (Ur. l. RS, No 14/2011) I propose to nominate Ms Jasna Gabrič as a candidate for membership of the delegation.

The mandate of Ms Gabrič at the local level will expire after the local elections due to be held in the autumn of 2014.
