- 1. - 2. The Agreement was signed on 26 June 2012, subject to its conclusion at a later date.

- 3. Following a letter from the Chairman of INTA, Professor Moreira, dated 4 June 2012, sent to the Minister for Trade and Investment of Denmark, and to the Trade Commissioner concerning the provisions, which confer implementing powers, included in some Council Decisions to conclude international trade agreements on 6 July 2012, the Trade Policy Committee (Deputies) re-examined the text of the draft Council Decision on the conclusion, and endorsed the revised draft Council Decision on the conclusion as set out in doc. 14762/1/11 REV 1 WTO 328 AMLAT 83 SERVICES 95 COMER 189 (text finalised by the legal/linguistic experts). The Trade Policy Committee also endorsed the Presidency suggestion to send a letter to the Chairman of INTA, Professor Moreira.

Dear Professor Moreira,

Further to the reply of Minister Pia Olsen Dyhr of 19 June 2012 to your letter dated 4 June 2012, the Cyprus Presidency would like to inform you that the Council decided on 10 July 2012 to forward to the European Parliament a modified draft Council Decision on the conclusion of the above-mentioned Agreement (doc. 14762/1/11 REV 1 WTO 328 AMLAT 83 SERVICES 95 COMER 189), updating the formal consent request transmitted to you on 28 June 2012.

Without prejudice to the final Council position on the Commission proposal for a *Regulation of the European Parliament and of the Council implementing the bilateral safeguard clause and the stabilisation mechanism for bananas of the Trade Agreement between the European Union and Colombia and Peru* (doc. 15088/11) and the outcome of negotiations in respect of that Regulation, the Cyprus Presidency would like to inform you about the readiness of the Council to consider favourably the inclusion of the provision contained in Article 5 of the Commission proposal for a *Council Decision on the conclusion of the Trade Agreement between the European Union and its Member States, of the one part, and Colombia and Peru, of the other part* (doc. 14760/11) into the above-mentioned Regulation.
