"STATEMENT BY THE CZECH REPUBLIC

The Czech Republic strongly supports the introduction the new risk based solvency regime pursuant to the Directive 2009/138 on the taking up and pursuit of the business of Insurance and Reinsurance (Solvency II). We believe it should be implemented and applied as soon as possible, but under circumstances that are reasonable for all respective stakeholders.

As the adoption of the proposal of the Directive amending Directives 2003/71 and 2009/138 in respect of the powers of the European Insurance and Occupational Pensions Authority and European Securities and Markets Authority (Omnibus II) has been delayed, we understand the urgent need to postpone the transposition and application of the Solvency II Directive. Only for these reasons we support the proposed Quick Fix Directive so as to avoid a state of legal vacuum after 1 November 2012.

However, in general, we have strong concerns whether the setting of the transposition and application dates is realistic. In our opinion, a period of six months, delimited by the dates 30 June 2013 and 1 January 2014, is not sufficient for preparation of all stakeholders to a new regime, especially not for approval procedures. It is far not certain whether the level 2 and level 3 measures will be adopted and published by 30 June 2013. A national legislation transposing the Solvency II Directive might not be in conformity with the level 2 and level 3 measures as their content will not be fixed in sufficient advance. Moreover, all stakeholders will have to prepare for the new regime according to legislation which will not yet be in force.

For these circumstances, which create a legal uncertainty, the Czech Republic will propose, within the Omnibus II Directive negotiations, postponement of application of the Solvency II Directive to 1 January 2015."

"STATEMENT BY SWEDEN

Sweden strongly supports the reform of the solvency and risk management regimes of insurance companies brought about by directive 2009/138 on the taking up and pursuit of the business of Insurance and Reinsurance (Solvency II). The directive should be implemented and applied as soon as reasonably possible. Regrettably, the adoption of the amendments to Solvency II included in the proposed directive amending directives 2003/71 and 2009/138 in respect of the powers of the European Insurance and Occupational Pensions Authority and European Securities and Markets Authority (Omnibus II) has been postponed. From our perspective, it is not possible to separate the transposition of the Solvency II directive from the transposition of the amending directive (Omnibus II) since the latter contains extensive changes to the substance of Solvency II. Omnibus II cannot be expected to be adopted until the autumn of 2012. At that point, the Swedish government is constitutionally required to put proposed amendments to national law, aiming to implement Omnibus II, to a public consultation. Further, the proposed legislation must be reviewed from a constitutional and legal perspective by the Council on Legislation. Naturally, the reading in Parliament then follows. That reading will take 2-3 months to complete. Regrettably, Sweden will, given the aforesaid, most likely not be able to comply with article 309 (1) of directive 2009/138, as amended by the proposal. Swedish national legislation transposing directive 2009/138, as amended by Omnibus II, cannot be adopted until the end of 2013 at the earliest."

The Summit had been short but helpful - in the immediate run-up to the G20 meeting - and very positive. Both the President of the European Council and the President of the Commission had asked Mexico, in its capacity as Chair of the G20, to play a constructive role in the coming debates while Mexico had explained its security policy. Furthermore, the major bilateral items had been concisely raised.

As to the financial crisis, the President of the European Council had explained the roadmap leading up to the European Council end of June. The focus of the Mexican questions was less the situation in Greece and more so the Spanish situation with a number of questions raised by the Mexican Finance Minister concerning the Spanish banking sector. Regarding security, the Mexican President had in particular elaborated on the three-pronged approach of his administration: facing the criminals, reforming the law and restoring the social fabric. This was put in practice with total respect for human rights. The overall figures for homicides etc. were not as bad as in other parts of Latin America, he added.

Regarding points of bilateral interest, the focus was on trade where trade and FDI flows had more than doubled over the last ten years and where now consideration should be given to an upgrade of the existing agreement, notably on Services and Investment. The Mexican President was receptive to this wish. Furthermore, both sides highlighted the need to fight protectionism. Other subjects raised included Climate Change and Sustainable Development where satisfaction was expressed given that both parties worked well together. Finally, as to Human Rights, two cases were mentioned by the European side which led to some form of discontent on the Mexican side since Mexico considered only one of these cases to be a Human Rights case, the other one being under judicial examination at the High Court.

Following the exchange at its meeting of 21 June 2012, <u>the Committee</u> decided to invite the Council to enter into the minutes of its meeting of 25 June 2012 a Joint Council and Commission declaration.
