### 1. Adoption of the agenda

The agenda as set out in CM 3636/12 was adopted, with the addition of one item under any other business (point 10).

### 2. Information by the Presidency

The Presidency handed out an information sheet containing contact details of the GENVAL team of the Cyprus Presidency, provisional dates for the GENVAL meeting during its Presidency, and dates for two seminars/conferences to take place in Cyprus in October.

The evaluation team presented the report. The Czech delegation commented on the findings of the evaluation team and replied to the questions asked by other delegations. The Presidency concluded that a revised version of the report will be presented for adoption at a next GENVAL meeting.

The evaluation team presented the report. The Slovene delegation commented on the findings of the evaluation team and replied to the questions asked by other delegations. The Presidency concluded that a revised version of the report will be presented for adoption at a next GENVAL meeting.

7. Trafficking in Human Beings - Presentation by the Presidency of a study on victims' protection in criminal proceedings

The Presidency initially stressed that one of its priorities would be preventing and combating trafficking in human beings. In view of supporting and complementing the newly adopted strategy of the Commission, it presented the study, which will focus on victims of human trafficking and their protection in criminal proceedings with the aim of identifying best practices. A questionnaire will be circulated before the summer holiday. The replies to the questionnaire will be analysed by the Presidency and presented in the form of a draft report at the GENVAL meeting of 3 October 2012.
