Presidency debriefing on the outcome of the informal trilogue

The <u>SCA</u> took note of the Presidency oral debrief on the agreement reached between the representatives of the three institutions at the informal trilogue held on 4 July 2012, in line with the mandate given to the Presidency on 2 July 2012 (doc. 11635/1/12 REV 1).

On this basis the SCA authorised the Chair of the SCA to send a letter to the Chair of the EP Committee on Agriculture stating that should the European Parliament adopt its position at first reading in the form set out in the text in the Annex to that letter (subject, if necessary, to revision by the legal linguists of both institutions), the Council would approve the European Parliament's position.

The SCA agreed to invite the Council to decide, during its meeting on 16 July 2012, as an "A" item of its agenda, for an extension of the time limit for raising objections on this delegated Regulation by two months (i.e. up to 28 October 2012).

Further, the Presidency informed delegations about its intention to examine again this issue at SCA level at the beginning of September in order to make possible a decision by the Council before 3 October 2012, date at which all the provisions of the basic legislative act become applicable.
