## THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 217, in conjunction with Article 218(5) and the first subparagraph of Article 218(8) thereof, Having regard to the proposal from the European Commission,

Whereas:
(1) On 18 June 2007 the Council authorised the Commission to negotiate a Protocol to the Euro-Mediterranean Agreement establishing an Association between the European Communities and their Member States, of the one part, and the Hashemite Kingdom of Jordan, of the other part ${ }^{1}$, on a Framework Agreement between the European Union and the Hashemite Kingdom of Jordan on the general principles for the participation of the Hashemite Kingdom of Jordan in Union programmes ("the Protocol").
(2) The negotiations have been concluded.
(3) The Protocol should be signed on behalf of the Union, subject to its conclusion.
(4) The Protocol should be applied on a provisional basis in accordance with Article 10 thereof, pending the completion of the procedures for its conclusion,

HAS ADOPTED THIS DECISION:

## Article 1

The signing of the Protocol to the Euro-Mediterranean Agreement establishing an Association between the European Communities and their Member States, of the one part, and the Hashemite Kingdom of Jordan, of the other part, on a Framework Agreement between the European Union and the Hashemite Kingdom of Jordan on the general principles for the participation of the Hashemite Kingdom of Jordan in Union programmes ("the Protocol") is hereby authorised on behalf of the Union, subject to its conclusion.

The text of the Protocol is attached to this Decision*.

## Article 2

The President of the Council is hereby authorised to designate the person(s) empowered to sign the Protocol on behalf of the Union.

## Article 3

The Protocol shall be applied on a provisional basis as from the date of its signature ${ }^{1}$, pending the completion of the procedures for its conclusion.

## Article 4

This Decision shall enter into force on the day of its adoption.
