<u>The Committee</u> received a briefing by the Presidency on the state of play following the suggestion by the Heads of State and Government on 29 June 2012 to remove Articles 6-8 from the Regulation.

The Committee agreed to return to this file at its next meeting.

9. Working programme of the Cyprus Presidency

Presidency presented to <u>the Committee</u> its Working programme "Working towards a better Europe" which is focused on 4 pillars :

- more efficient and sustainable Europe including notably the Multiannual Financial Framework (MFF), the Common Agriculture Policy (CAP) and the Common Fisheries Policy (CFP) reform, the cohesion policy, the energy policy, the maritime policy;
- Europe with a better performing and growth-based economy including notably the internal market and its digital dimension and the Small and Medium-sized enterprises (SMEs);
- Europe more relevant to its citizens, with solidarity and social cohesion including notably youth employment, active ageing, health and children's wellbeing;
- Europe in the world, closer to its neighbours.

The Committee prepared the exchange of views on the Communication on Fishing Opportunities. The French delegation emphasised that the Committee should fully play its role when it comes to preparing the Fisheries Council. In addition, the French, Spanish and Portuguese delegations underlined their disagreement with the Commission's intention to continue splitting the internal and external TAC and quota proposals.

AOB: mackerel and the trade measures instrument

The <u>Irish delegation</u>, supported by <u>the Spanish</u>, <u>Portuguese and French delegations</u>, requested the inclusion of an AOB on the Council's agenda regarding the North-East Atlantic mackerel management. This request has been accepted by the Presidency.

After a discussion, the Committee could not give its support to option b) as set out in paragraph 10 of document 12116/12, that foresaw the possibility of combining elements of a roll-over of the ASW quotas from the previous period, with the introduction of some flexibility with regard to the new quotas presented by DK (on behalf of Greenland) to IWC 64 for the next 5-year period. The Committee only supported a roll-over of the ASW quotas for Greenland, i.e. an automatic extension of the quotas set for the previous 5-year period (2008-2012). A roll-over had been supported by the EU and its Member States and accepted by all at IWC 64 for the other three Parties to the International Convention on the Regulation of Whaling that submitted a request for an ASW quota for the next period.

36. Follow-up to the Council meeting (Foreign Affairs) on 25 June 2012

<u>The Committee</u> received a briefing on the follow-up to the Foreign Affairs Council of 25 June 2012.

The following items were highlighted:

- Southern neighbourhood: as to Syria, it is important to start work on broadening of sanctions without any delay; as to Egypt on the best way to support transition;
- Bosnia Herzegovina: positive developments;
- Pakistan, the HR reported from her visit;
- the new EUSR for Human Rights would be appointed soon.

No delegation intervened.

37. Presentation of the agenda of the Council meeting (Foreign Affairs) on 23 July 2012

The EEAS Executive Secretary General, Mr. Pierre Vimont, presented the agenda for the incoming Foreign Affairs Council on 23 July 2012.

The following items are expected to be included on July FAC:

Southern Neighbourhood (Syria and Libya), Sudan and South Sudan, Mali/Sahel, CSDP, (poss.) DRC, Energy and Foreign Policy, China, (poss.) Cuba, as well as A points regarding further restrictive measures against Syria and Council conclusions on Somalia. No delegation intervened.

38. Follow-up to the Council meeting (General Affairs) on 26 June 2012

Presidency recalled the important decisions taken by the GAC, notably the decision to open accession negotiations with Montenegro, the partial approach on the Cohesion legislative package and the endorsement of the Country Specific Recommendations (CSR).

39. Presentation of the agenda of the Council meeting (General Affairs) on 24 July 2012

Presidency presented to the Committee the items which are expected to be included in the agenda of the July GAC:

- MFF;
- Presidency's working programme;
- follow-up to the June 2012 European Council.

40. Follow-up to the European Council (28/29 June 2012)

The Committee had an exchange of views on the results and expected follow-up of the EC on 28/29 June 2012, notably as regards the Country Specific Recommendations, the EMU report, the agreement on the patent, the compact growth and jobs.

41. Follow-up to the Council meeting (Economic and Financial Affairs) on 22 June 2012

- The Council approved the country-specific recommendations in the framework of the
 European semester applying for the first time the so-called "comply or explain"
 principle. This implies that the Council explains in a public report the cases in which it
 deviates from the Commission's recommendation.
- The Presidency concluded that support for a Financial Transaction Tax as proposed by the Commission was not unanimous. It noted that a significant number of delegations are open to considering enhanced cooperation.
- During the lunch, Ministers had an exchange of views on the well-known positions of Member States on the 2014-2020 Multiannual Financial Framework.
- After lunch, Ministers had an orientation debate on key questions related to the Energy
 Taxation Directive, with a particular focus on the structure of the tax, and provided
 some guidance for future work. Cyprus announced that it will take this file forward
 during its Presidency.
- The bank resolution item was moved to the July ECOFIN.
