Mr Manthos MAVROMMATIS

- He was born in Nicosia in 1957.
- He holds a B.Sc. (Econ.) degree from the London School of Economics and an MBA from the Business School of the University of Chicago.
- He is the General Manager of the family business and a member of the Board of other private companies.
- He served as Chairman of the Cyprus Youth Organisation and as a member of the Board of the Cyprus State Fairs Authority.
- He served as Chairman of the Board of the Nicosia Chamber of Commerce and Industry. He was elected Chairman of the Cyprus Chamber of Commerce and Industry in 2005, a position that he held until November 2011. He is responsible for the co-ordination of the 27 bi-national business associations of the Cyprus Chamber of Commerce and Industry.
- After the accession of Cyprus to the European Union he represented the Cyprus Chamber of Commerce and Industry for two years in the European Economic and Social Committee (EESC) in Brussels, which is the institutional body at European level for social partners.
- He represents Cyprus in the Chamber of Commerce which is the advisory body to the Directorate General for Entrepreneurship of the European Council in Brussels.
- He is a member of the Board of Directors of Bank of Cyprus since 2005.
- He is a member of the Board of the University of Nicosia Research Promotion Foundation, of the Cyprus International Institute of Management and of the Board of Trustees of the Research and Educational Institute of Cyprus.
- He is the Honorary-Consul of Mexico in Cyprus. On 12 January 2012 he was appointed Senior Independent Director."
