- 1. <u>The General Secretariat of the Council</u> has been informed of the resignation of Ms Maria THEOCHARIDOU, as alternate member of the above Committee in the trade union representatives category (for Cyprus).
- 2. Under Article 3 of Decision 2003/C 218/01, members and alternate members are appointed by the Council.

## THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003<sup>1</sup> on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- In its Decisions of 16 February 2010<sup>2</sup>, 22 March 2010<sup>3</sup>, 29 March 2010<sup>4</sup>, 19 April 2010<sup>5</sup> and 21 March 2011<sup>6</sup> the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2013.
- (2) A seat as alternate member in the trade union representatives category has fallen vacant as a result of the resignation of Ms Maria THEOCHARIDOU.
- (3) The government of Cyprus has nominated a candidate for the vacant seat,
