Subject: Proposal for transfer of appropriations No DEC 25/2012 within Section III -

Commission - of the general budget for 2012

1. On 29 August 2012, the Commission submitted to the Council proposal for transfer of appropriations No DEC 25/2012.

The purpose of this proposal is to increase the commitment appropriations under Articles 23 02 01 (*Humanitarian aid*) and 23 02 02 (*Food aid*) by EUR 80 million and EUR 15 million respectively. The necessary funds will be partially redeployed from Item 19 08 01 01 (*European Neighourhood and Partnership- financial cooperation with Mediterranean countries*) (EUR 11.36 million) and from Article 23 03 06 (*Civil protection interventions in third countries*) (EUR 4 million). The Emergency Aid Reserve (Article 40 02 42) will be used in order to cover the remaining EUR 79.64 million, as recorded in document 13259/12 FIN 613.

The necessary payment appropriations requested, amounting to EUR 64 million, will be entirely drawn from the Emergency Aid Reserve.

- 2. The transfer is being proposed in order to answer to additional needs deriving from the on-going humanitarian and food crises in Syria (EUR 50 million), Pakistan (EUR 15 million) and the Horn of Africa (EUR 30 million).
- 3. The Budget Committee examined this proposal for a transfer at its meeting on 4 September 2012.
- 4. In accordance with the provisions of Point 25 of the Interinstitutional Agreement of 17 May 2006, a simplified trilogue was held on the Commission proposal.
- 5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
  - the proposed transfer of appropriations;
  - the draft letter in ANNEX to that effect.
