Pursuant to Article 19(1) of the Law of 6 May 2005 on the Joint Committee of the Government and Local Government and the representatives of the Republic of Poland in the Committee of the Regions of the European Union (Polish Journal of Laws, 2005, No 90, section 759), I have the honour to enclose a list containing the names of two candidate alternate members of the EU Committee of the Regions. In accordance with the applicable law, the Council of Ministers places on that list candidates recommended by the local government side of the Joint Committee of the Government and Local Government. On 9 May 2012, at the request of the Minister for Administration and Digitalisation, the Council of Ministers resubmitted its Decision of 10 November 2009 adopting the list of candidate members and alternate members of the EU Committee of the Regions for the period 2010 to 2015, adding the names of Mr Piotr Całbecki and Mr Jarosław Dworzański as alternate members of the Committee of the Regions of the European Union. The list was approved by the European Union Affairs Committee of the Sejm of the Republic of Poland on 25 July 2012.

In view of the above, I would respectfully request that the appropriate procedures be initiated with regard to the designated candidate alternate members of the Committee of the Regions of the European Union.
