Thank you for your interest.

The General Secretariat of the Council has examined your requests on the basis of Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (Official Journal L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, Official Journal L 325, 11.12.2009, p. 35). The time-limit for replying to your application has been extended. Having examined the requests, the General Secretariat has come to the following conclusion:

### Preliminary note:

EU classified information is classified at one of the following level, among others<sup>1</sup>: "RESTREINT UE/EU RESTRICTED": information and material the unauthorised disclosure of which could be disadvantageous to the interests of the European Union or of one or more of the Member States.

You may have access to documents **11984/09**, **15689/1/09 REV 1** and **15689/2/09 REV 2**.

Documents 10081/09, 10111/09, 10439/09, 10819/09, 10676/09, 11142/09, 11332/09, 11442/09, 11459/09, 11651/09, 12863/09, , 12764/09, 12754/09, 12743/09, 12690/09, 12612/09, 12644/09,12584/09,12503/09, 12310/09,12163/09, 11954/09, 11262/09, 11262/1/09 REV 1, 11741/09, 12946/09, 13363/09, 13369/09, 13158/09, 13514/09, 14184/09, 13893/09, 14183/09, 14503/09, 14839/09, 15081/09, 13894/09, 14025/09, 15456/09 and 15852/09 (all classified "EU RESTRICTED") contain various EULEX KOSOVO mission reports.

These documents contain internal reports with operational details on EULEX KOSOVO. Release of these details would weaken the mission's effectiveness and seriously affect relations with the third parties concerned, all the more so as the mission has to operate on the background of a delicate political situation on the international level.

Accordingly, pursuant to Article 4(1)(a) of the Regulation (public security), and to Article 4(1)(a) of the Regulation (international relations), the General Secretariat cannot grant you access to these documents.

As the exception applies to the content of the entire documents, the General Secretariat is not able to grant you partial access as provided for in Article 4(6) of the Regulation, either.

Documents 11751/09 and 11751/1/09 REV 1 are a note (and its revised version) from the Secretariat to the Committee for Civilian Aspects of Crisis Management (CivCom) containing Draft CivCom advice on the EULEX KOSOVO Monthly Report 02/09, document 12083/09 is a note from the Committee for Civilian Aspects of Crisis Management to the Political and Security Committee, containing the corresponding adopted version of the advice.

As these documents refer to mission reports as mentioned above, they relate to the same kind of information and the same reasons as set out above make it necessary to refuse these documents (thus pursuant to Article 4(1)(a) of the Regulation (public security), and to Article 4(1)(a) of the Regulation (international relations)).

Document **12568/09** is a note from the General Secretariat of the Council to delegations and concerns *Council Joint Action 2009/ /CFSP of amending Council Joint Action 2009/137/CFSP extending the mandate of the European Union Special Representative in Kosovo (under United Nations Security Council Resolution 1244 (1999)) - Financial statement.* 

Pursuant to Article 4(6) of the Regulation, you may have access to this document with the exception of some which might allow to draw conclusions on the situation of individual people and which therefore constitute personal data in the sense of the Data Protection Regulation<sup>1</sup>. Access to this information must be refused pursuant to Article 4(1)(b) of the Regulation (protection of privacy and the integrity of the individual), as it was not possible to obtain the individual consent of the persons concerned.

Document **14269/09** contains an opinion of the Legal Service on a *Draft accountability* concept paper proposing the setting up of a human rights review panel for EULEX Kosovo.

The document contains internal information on the contents of the draft accountability concept paper proposing the setting up of a human rights review panel for EULEX Kosovo. Its release would affect the working of the mission and undermine the international relations of the EU with relevant third parties.

The divulgation of the content of the document would also undermine the protection of legal advice by revealing to the public internal opinions of the Council Legal Service, intended for the members of the Council. This would entail the risk to lead the Council to display caution when requesting opinions from its Legal Service, since it could find itself weakened by a published opinion of the Legal Service, after having adopted a different interpretation of the legal issue at stake. Moreover, the Legal Service could come under external pressure which could affect the way in which legal opinions are drafted and hence prejudice the possibility of the Legal Service to express its views free from external influences.

Accordingly, pursuant to Article 4(1)(a), first and third indents (protection of the public interest with regard to public security and to international relations) and, in the absence of any evidence suggesting an overriding public interest to warrant disclosure, also pursuant to Article 4(2) second indent (protection of court proceedings and legal advice) of the Regulation, the General Secretariat is unable to grant full access to this document.

However, pursuant to Article 4(6) of the Regulation, you may have access to those parts of the document which are not covered by this exception.

Document **15700/09** contains the outcome of proceedings of the Foreign Relations Counsellors Working Party meeting of 9 November 2009 concerning *EULEX KOSOVO* – *Third Party Liability Insurance*.

It contains internal assessments, release of which would affect the functioning of the mission and relations with relevant third parties as well as have an impact on future missions.

Accordingly, pursuant to Article 4(1)(a), first and third indents of the Regulation (protection of the public interest with regard to public security and to international relations), the General Secretariat is unable to grant full access to this document.

However, pursuant to Article 4(6) of the Regulation, you may have access to those parts of the document which are not covered by this exception.

Document **15260/1/09 REV 1** is a cover note from the Council Secretariat to the Committee for Civilian Aspects of Crisis Management containing a *Draft revised Operation Plan (OPLAN) for the European Union Rule of Law Mission in Kosovo, EULEX KOSOVO.* 

Document **13775/09** is a note from the General Secretariat of the Council to the Committee for Civilian Aspects of Crisis Management containing a *Draft revised Annex A of the Operation Plan (OPLAN) for the European Union Rule of Law Mission in Kosovo, EULEX KOSOVO.* 

These two documents contain information of an operational nature release of which would weaken the mission concerned and affect relations with relevant third parties. Disclosure of this information would thus undermine the protection of the public interest as regards public security and international relations and therefore must be denied pursuant to Article 4(1)(a), first and third indent, of the Regulation.

#### Statutory remedy notice

Pursuant to Article 7(2) of the Regulation, you may submit a confirmatory application requesting the Council to reconsider this position, within 15 working days of receiving this reply<sup>1</sup>.

<u>Subject</u>: Reconsideration upon the Council of its position pursuant to Article 7 (2) of Council Regulation No 1049/2001

To the attention of the General Secretariat of the Council of the European Union,

in your e-mail of the 30<sup>th</sup> of July 2012 and on the basis of the request forwarded to you on various documents pertaining to EULEX Kosovo, I got the following feedback:

(a) Documents 10081/09, 10111/09, 10439/09, 10819/09, 10676/09, 11142/09, 11332/09, 11442/09, 11459/09, 11651/09, 12863/09, 12764/09, 12754/09, 12743/09, 12690/09, 12612/09, 12644/09, 12584/09, 12503/09, 12310/09, 12163/09, 11954/09, 11262/09, 11262/1/09 REV 1, 11741/09, 12946/09, 13363/09, 13369/09, 13158/09, 13514/09, 14184/09, 13893/09, 14183/09, 14503/09, 14839/09, 15081/09, 13894/09, 14025/09, 15456/09 and 15852/09; Documents 11751/09 and 11751/1/09 Rev 1; Document 12083/09; (all classified "EU RESTRICTED") contain various EULEX KOSOVO mission reports. These documents refer to internal reports containing the operational details of EULEX KOSOVO. As reported in the General Secretariat of the European Council, the release of these documents would weaken the mission effectiveness and affect the third parties concerned;

(b) concerning Document **12568/09** it has been reminded to me that pursuant to Article 4(6) of the Regulation (EC) No 1049/2001, I may have access to this document with the exception of some of its parts which might allow to draw conclusions on the situation of individual people and which therefore constitute personal data in the sense of the Data Protection Regulation (EC) No 45/2001;

(c) Document **146269/09** refers to internal information on the content of the draft accountability concept paper proposing the setting up of a human rights review panel for EULEX Kosovo. In your e-mail of the 30<sup>th</sup> of July 2012 I got information that the release of this document may affect the working of the mission and undermine the EU's international relations with relevant third parties. Furthermore, its release may also undermine the protection of legal advice by giving access to the public to the internal opinions of the Council Legal Service, intended for the members of the Council. This would imply for the Legal Service to be put under external pressure which may affect the way in which legal opinions are drafted and thus prejudice the possibility of the Legal Service to express its views free from external influences. You argued under the letter of Article 4(1) (a), first and third indents (protection of the public interest with regard to public security and to international relations) and, provided that there is no evidence for an overriding public interest to warrant disclosure, and also in conformity with Article 4(2) second indent (protection of court proceedings and legal advice) of the Regulation, that the General Secretariat is not allowed to disclose the content of this document. But, in conformity with Article 4(6) of the Regulation, access has been granted to me to those parts of the document which are not covered by this exception.

(d) Document **15700/09** refers to the outcome of the proceedings of the Foreign Relations Counsellors Working Party meeting of 9 November 2009 concerning EULEX KOSOVO – Third Party Liability Insurance. It refers to internal assessments whose disclosure may affect the functioning of the mission and relations with relevant third parties and it may also have an impact on future missions. This said, in conformity with Article 4(1) (a), first and third indents of the Regulation (protection of the public interest with regard to public security and to international relations), the General Secretariat is not allowed to release the whole content of this document. However, in conformity with Article 4(6) of the Regulation, access has been granted to the author to those parts of the document which are not covered by this exception. (e) Document **15260/1/09 REV 1** and Document **13775/09** refer to information of an operational nature whose content's disclosure may weaken the mission as well as affect its relations with relevant third parties. The release of this information may undermine the protection of the public interest concerning public security and international relations and thus it must be denied in conformity with Article 4(1) (a), first and third indent, of the Regulation referred above.

I write to you by reminding that pursuant to Article 7(2) of the Regulation, it is possible to submit a confirmatory application requesting the Council to reconsider this position, within 15 working days after receiving this reply.

Here I write to you to ask the Council to reconsider its position.
