1. Adoption of the provisional agenda

The <u>SCA</u> approved the summary record.

3. Proposal for a regulation of the European Parliament and of the Council establishing rules for direct payment to farmers under support schemes within the framework of the common agricultural policy

The SCA considered further Presidency suggested amendments on the basis of document 13206/12

The SCA noted the Presidency's summary of the discussion, the main points of which were as follows:

- on the allocation of payment entitlements (Articles 18 and 21) some delegations supported the suggested amendments aiming to provide Member States who face problems related to traditional land tenure patterns and short term contracts with the option of requiring additional proof where the legality of access to or use of the land is in doubt. Other delegations could go along with the Presidency suggestions provided that any such provision remained optional. A number of delegations questioned whether the suggested amendments were necessary or requested further clarification.
- on the national reserve (Article 23) several delegations supported the suggested extension to allow Member States to compensate farmers facing exceptional circumstances. Some delegations had objections or requested further clarification.

- on the activation of payment entitlements (Article 25) <u>some delegations</u> supported the suggested clarification regarding the eligibility of land that was classified as not having been in good agricultural condition on 30 June 2003 but was later maintained in such condition. <u>Other delegations</u> considered such a clarification superfluous or requested further clarification. <u>A few delegations</u> supported the suggestion to widen the possibility to use the reduction coefficient to areas which were not in good agricultural condition in 2003. <u>Some delegations</u> requested a broader discussion on the scope and application of a reduction coefficient or further clarification.

The <u>SCA</u> further took note of delegations' comments relating to other aspects of the text, of the scrutiny reserves entered by some delegations, as well as of the reaction by the Commission representative.

The <u>SCA</u> finally took note of the Presidency's invitation for written comments to be submitted to the General Secretariat by the end of the week, as well as of its intention to reflect on the outcome of the discussion.

4. <u>Proposal for a regulation of the European Parliament and of the Council establishing a common organisation of the market in agricultural products (Single CMO regulation)</u>

The <u>SCA</u> held a discussion on the definition of "adult bovine" animal on the basis of a Presidency paper (doc. 13205/12).

The <u>SCA</u> took note of the Presidency's summary of the discussion and in particular that there was broad support for the Commission proposal to switch from a weight based to an age-based criterion for the purposes of public intervention, private storage and carcass classification of bovine animals. Most delegations were open to removing the word "adult" from that age-based criterion. Although most delegations supported an age criterion of "8 months or more" many delegations considered 12 months was more appropriate.

It was also noted that of those who could accept an age criterion of 8 months, some considered that if the definition of adult bovine were retained the age criterion should be 12 months.

The scrutiny reserve of <u>one delegation</u> was noted.

The <u>SCA</u> also took note of the comments of the Commission representative and, in response to several delegations, that in its view the emerging approach was compatible with the separate issue of definitions, designations and sales description in the beef and veal sector as provided for in Annex VI of the draft Single CMO Regulation.

The <u>SCA</u> finally took note of the Presidency's invitation for written comments to be submitted to the General Secretariat by the end of the week as well as of its intention to reflect the outcome of the discussion in a revised text for discussion by the Working Party on Horizontal Agricultural Questions.
