**2. Conclusion of the Agreement between the European Union and the People's Democratic Republic of Algeria on cooperation in science and technology**

**7. Interim report in the interests of achieving a positive outcome of the Multiannual Financial Framework 2014-2020 approval procedure (2011/0177(APP))**

2011/0177(APP), COM(2011)0398, ITRE/7/09788

Rapporteur for the opinion: Edit Herczog (S&D, HU)

Committee responsible: BUDG

The rapporteur, Ms Herczog, said that the Parliament would not be ready to vote on the MFF final numbers unless related files under the ordinary legislative procedure (e.g. Horizon 2020, COSME and CEF) had advanced further. She underlined three key issues: the size of the budget, own resources and the correction mechanisms. She gave a brief overview of her suggestions, highlighting in particular a need for EUR 1 600 billion for the competitiveness sector; the European added value (EAV) offered by the EU budget; the simplification of funding procedures for Horizon 2020; large infrastructure projects and related risks of cuts and overrun costs; and the project bonds and risk-sharing financing instrument. She also inquired about the unused revenues and margins.

Members raised the issues of greater support for SMEs (Ms Sartori (EPP, IT), Mr Kelly (EPP, IE)), including the transfer of company property (Ms Sartori), a need to mobilise private capital, support for the project bonds and expansion of COSME (Mr Rübzig (EPP, AT)) through the reallocation of funds from less effective programmes (Mr Creutzmann (ALDE, DE)), guaranteed funding for large-scale projects (Ms Sartori), including opposition to the removal from the MFF of spending on ITER and GMES (Mr Creutzmann, Mr Prodi (S&D, IT)), budget expenditure to be focused on EAV and increasing competitiveness (Mr Creutzmann), and own resources (Mr Rübzig, Mr Kelly).

The Commission representative informed members that an extraordinary European Council meeting dedicated to the MFF would take place in November. Therefore he advised the Parliament to have its position ready by then.

The rapporteur concluded that the objective was to secure an amount for the competitiveness heading which was at least equal to the amount proposed by the Commission.

## **8. The role of EU cohesion policy and their actors in implementing the new European energy policy**

Rapporteur for the opinion: Ioan Enciu (S&D, RO)

Committee responsible: REGI

The rapporteur, Mr Enciu, focused on the energy efficiency as a factor in cohesion policy, the use of renewables, in particular in the housing sector, the allocation of financial resources to even out regional disparities, energy poverty, and the simplification of access to the structural funds.

During the discussion, members highlighted energy efficiency as a tool for tackling energy poverty and controlling costs (Mr Turmes (Greens/EFA, LU)), a better use of structural funds, in particular in the building sector (Ms Țicău (S&D, RO)), the role of structural funds in the development of certain geographical areas to mitigate the effects of climate change (Mr Prodi (S&D, IT)), renewables (Mr Prodi, Ms Țicău) as a means of local development, the subsequent need for local grids and the related flexibility for regions in selecting projects (Ms Kolarska-Bobińska (EPP, PL)), incentives for young entrepreneurs (Mr Rübzig (EPP, AT)), biomass (Mr Prodi, Mr Helmer (EFD, UK)), and shale gas and its exploration in the EU and the US (Mr Helmer, Mr Turmes, Mr Goebbels (S&D, LU)).

The Commission representative also acknowledged the win-win effect of investment in energy efficiency and renewables for SMEs in the construction sector; in creating local jobs, helping to fight energy poverty etc. Concerning the financing instruments, she said that the objective was greater use of instruments other than loans in the next programming period. With regard to queries on flexibility, she underlined the advantage of combining two policies, allowing investments to be tailored to specific local circumstances.

## **9. Debriefing from the ITRE delegation to Cyprus**

Mr Goebbels (S&D, LU), the head of delegation, briefly informed members about the visit. He gave an overview of the situation resulting from the recent discovery of gas fields in Cyprus, explaining that Turkey was contesting Cypriot sovereignty over these. He considered that the EU should show solidarity with Cyprus, saying that it had an absolute right to exploit the gas. In this context, he informed members about the Presidency's intention to organise a ministerial meeting later in the year on the future of energy in the Mediterranean involving EU Member States as well as other countries in the region. He also raised the issue of the Council decision on the Schengen evaluation mechanism, noting that Cyprus initially wanted to vote against it, but had eventually decided to vote in favour.
