<u>SE</u> made a statement on the following item:

67. a) Council implementing Decision implementing Decision 2011/782/CFSP concerning restrictive measures against Syria

"It is evident that all measures taken by the EU against a third State must be fully consistent both with international law and the rule of law.

In the context of the new Council Decision before us on measures amending Council Decision 2011/782/CFSP concerning restrictive measures against Syria, Sweden would like to note that under international law ships of all states enjoy the right of innocent passage through the territorial sea of another state as long as it is not prejudicial to the peace, good order or security of the coastal State. Inspection of foreign ships in innocent passage cannot take place without the consent of the flag state. This follows from customary international law and is codified in the United Nations Convention on the Law of the Sea, to which also the EU is a party.

States may also be bound by long-standing international conventions that regulate passage in straits, such as the conventions applicable to the strait between Sweden and Denmark (Oresund), as well as to the strait between Sweden and Finland (the Aland islands).

Sweden would like to underline the importance of Article 17b para.2 that any measure relating to the seizure and disposal of cargo must be done in accordance with their national legislation and consistent with international law.

It is the intention of Sweden to apply the new measures in a manner that is fully consistent with its obligations under international law, including relevant treaty provisions."

At its 18 July 2012 meeting, the Committee took note of the Commission letter of 27 June 2012 (doc. 12118/12), which was addressed to the President of the Council, inviting the Council to adopt within two months its proposal of 24 November 2011 for a Council Regulation adjusting, from 1 July 2011, the rate of contribution to the pension scheme of officials and other servants of the European Union (doc.17625/11).

It appeared that the qualified majority necessary to adopt the Commission proposal was still not met and therefore, <u>the Committee</u> concluded that the Council should be invited to take note of that letter.

DK made the following statement:

"Denmark is against the proposal. Denmark would note its opposition in principle to the method of adjusting the remuneration and pensions of EU officials, given the high level of salaries in the EU institutions."

"The Commission considers that the provision of Article 27(3), fourth sub-paragraph should be interpreted in the sense that the time limits foreseen in Articles 21, 23, 23A and 28 are calculated taking into account the period already lapsed with the detention procedure.

In these cases, the period of one month for submitting a take charge or take back request and the period of six weeks for carrying out the transfer to the responsible Member State shall be deducted from the periods referred to in Articles 21, 23 and 28."
