Subject: Renewal of the Governing Board of the European Centre for the Development of Vocational Training (CEDEFOP)
Appointment of:
- **Mr Dimitrios V. SKIADAS** (EL), member in the category of Government representatives

1. The term of office of the members of the Governing Board of the European Centre for the Development of Vocational Training (CEDEFOP) will expire on 17 September 2012.

Under Article 4 of Regulation (EEC) No 337/75, as amended by Regulation (EC) No 2051/2004, the members of the Governing Board, except for the Commission's representatives, are appointed by the Council for a period of three years.

2. The General Secretariat of the Council has been informed by the Greek Government of its decision to nominate **Mr Dimitrios V. SKIADAS** as its member in the category of Government Representatives on the CEDEFOP Governing Board.
3. The Permanent Representatives Committee could therefore suggest that the Council:
 - adopt the Decision annexed hereto as an "A" item on its agenda, and
 - request that it be published in the Official Journal of the European Union for information.

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof ¹,

Having regard to the nomination submitted by the GREEK Government,

Whereas:

- (1) By its Decision of 16 July 2012 ², the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2012 to 17 September 2015.
- (2) The members of the Governing Board of that Centre should be appointed for a period of three years,
