- 1. The term of office of the members of the Governing Board of the European Centre for the Development of Vocational Training (CEDEFOP) will expire on 17 September 2012.
 - Under Article 4 of Regulation (EEC) No 337/75, as amended by Regulation (EC) No 2051/2004, the members of the Governing Board, except for the Commission's representatives, are appointed by the Council for a period of three years.
- 2. The <u>General Secretariat of the Council</u> has been informed by the Greek Government of its decision to nominate **Mr Dimitrios V. SKIADAS** as its member in the category of Government Representatives on the CEDEFOP Governing Board.

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof ¹,

Having regard to the nomination submitted by the GREEK Government,

Whereas:

- (1) By its Decision of 16 July 2012 ², the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2012 to 17 September 2015.
