<u>The Committee</u> agreed the provisional agenda for the forthcoming Council meeting (Agriculture and Fisheries) on 24 and 25 September 2012 as set out in 13827/12.

Following a request from the French delegation, the Presidency announced that the issue of the result of the vote at the Codex Commission in July 2012 on the adoption of ractopamine MRLs, will be treated under AOB in next September AGRIFISH Council and gave a mandate to the Codex Working Party to elaborate further on the issue and prepare a document for discussion at October AGRIFISH Council.

= Single market Act I (requested by the FI delegation)

<u>The Committee</u> took note of a request addressed by the Finnish delegation to the Presidency for information on the state of play of Single Market Act I and a suggestion for a discussion in <u>the Committee</u> on how to best advance remaining outstanding files. This request was supported by a number of delegations. The Chair informed <u>the Committee</u> that a GSC note on European Council follow-up would be presented in the first week of October to serve as a basis for a debate on this issue.
