Exchange of views

After presentation by the Presidency of its non-paper, delegations discussed the proposals and generally welcomed the effort to improve the working methods of the Competitiveness Council. Several delegations proposed to enlarge the scope and called for a discussion on substance and the role of the Competitiveness Council in the overall EU governance of growth initiatives. The Presidency, taking note of these interventions, announced that it will submit a revised version of the non-paper for the lunch debate of Ministers at the Competitiveness Council on 11 October 2012.

The Committee endorsed the Presidency proposal as set out in the 4th column of the Annexes of document 13399/12, with the exception of:

- Articles 3 and 6 where the text of the General Approach agreed at the Competitiveness Council of 30 May 2012 is kept,
- the deletion of "minimum" in recitals 3b, 17a and 23b, and
- Article 18 which refers to the whole Directive instead of to Article 10 only as in the General Approach.

On this basis, a mandate was given to the Presidency to enter into informal negotiations with representatives of the European Parliament and the Commission.
