The <u>SCA</u> took note of delegations' views and of the Commission's reply. This issue was referred to Council for political consideration.

To follow up on the discussion on 3 September 2012, the <u>SCA</u> considered further Presidency suggested amendments on the basis of document 13206/1/12 REV 1.

The <u>SCA</u> noted the Presidency's summary of the discussion, the main points of which were as follows:

- Overall the <u>Presidency</u> noted that <u>delegations</u> considered the text to be an improvement.
- The suggested clarifications in **Article 18** and **Article 21(1) and (2)**, were <u>broadly</u> supported as an improvement, although <u>a few reserves</u> on the **new paragraph d) of Article 21(2)** were noted.

- While some delegations supported the reworded paragraph (3a) of Article 21, provided this provision remained optional, several others requested further improvement or clarification.
- There was <u>broad support</u> for the clarification in Article 23(5)(a), although the continued concerns of some delegations on the inclusion of "force majeure or exceptional circumstances" were noted.
- <u>Delegations</u> were generally open to the suggested possibility in Article 23(5)(c) to use the national reserve for allocating payment entitlements to "cross-border farmers", provided such a provision remained optional; several requests for clarification were noted.
- <u>Delegations</u> supported the suggested amendment to **Article 25(2)(a)**.
- Delegations were generally open to the suggested amendment to Article 25(2)(b) to exclude areas which are predominantly used for non-agricultural activities, while one reservation and a few requests for clarification were noted.
- Most delegations supported the amended text on the reduction coefficient in Article 25(2)(b), with some delegations reiterating their request for a broader discussion on this issue.

The SCA further took note of delegations' comments and requests relating to other aspects of the text, as well as of the comments made by the Commission representative.

The SCA finally noted the Presidency's invitation for written comments and/or drafting suggestions to be submitted to the General Secretariat by the end of the week, as well as of its intention to reflect on the outcome of the discussion.

The SCA held a discussion on Article 43(3) TFEU on the basis of a Presidency paper (doc. 13512/12).

The SCA noted the Presidency's summary of the discussion, the main points of which were as follows:

- 1. On the fixing of the reference price for products subject to intervention, a very large majority considered this decision should be taken by Council under Article 43(3).
- 2. On the fixing of intervention prices, a very large majority considered this decision should be taken by Council under Article 43(3). Moreover, <u>many delegations</u> confirmed that the Commission should continue to apply these prices taking into account varying product quality in the final price. Delegations considered that it was not necessary to give the Commission further powers in this field.
- 3. On the fixing of private storage aid, without prejudice to delegations' political positions on the scope, a very large majority considered that this decision should be taken by Council under Article 43(3). Many delegations confirmed that the Commission should continue to be given the power to set the level of aid. Delegations considered that it was not necessary to give the Commission further powers in this field.
- 4. On the school milk scheme, all delegations were in favour of the fixing of Union aid being decided upon by Council under Article 43(3). A very large majority considered that the level of aid for milk, as well as the maximum quantity of milk equivalent eligible for aid, should be fixed directly by the Council. A very large majority indicated that for eligible milk products other than milk, the Commission should continue to determine the amount of aid.

- 5. On the school fruit scheme, <u>a very large majority</u> considered that the Council should determine the level of Union aid under Article 43(3). The Presidency also noted that while there was <u>broad support</u> that the Council should decide on the conditions applicable to each participating Member State and the minimum aid amount per Member State, <u>a</u> few reserves were also entered. A very large majority agreed that the Commission should be able to continue to decide on the definitive allocation of aid between Member States.
- 6. Finally on export refunds the Presidency noted that, without prejudice to delegations' political positions on export refunds, a very large majority supported the Commission proposal that the fixing of export refunds should be taken by the Council under Article 43(3), that the Commission should continue to be given the power to fix export refunds and their adjustment, and that the list of powers proposed was complete.

The <u>SCA</u> further took note of the scrutiny reserves entered by some delegations, as well as of the reaction by the Commission representative.

The <u>SCA</u> finally took note of the Presidency's invitation for detailed written comments to be submitted to the General Secretariat by the end of the week, as well as of its intention to reflect on the outcome of the discussion.

6. Proposal for a Regulation of the European Parliament and of the Council amending Council Regulation (EC) No 834/2007 on organic production and labelling of organic products

The Presidency required some indications from delegations on the way to proceed on this dossier. Delegations were asked whether they considered that it was still possible to get closer to EP's views and negotiations should be reopened in an early second reading exercise or whether they were of the view that all possible efforts had already been made to get an agreement with the European Parliament. In such a case, the Presidency suggested that this dossier could be put on hold for the time being, the current Regulation (EC) No 834/2007 remaining in force.

 The Council Legal Service confirmed that although the Council must take action, it is not bound by any time constraint to adopt its own first reading position. Following comments raised by two delegations, the Presidency agreed to give more time to delegations to reflect on this issue and to table again this item at a next SCA.

7. Organisation of future work

<u>The Presidency</u> informed the <u>SCA</u> on the preparation for the Council "Agriculture and Fisheries" on 24-25 September 2012.
