The European Parliament placed part of the 2012 SIS II (Schengen Information System) appropriations into the reserve, with the condition that these appropriations would be released "when the Commission submits a concrete and realistic schedule for the further development of SIS II in the financial year 2012, specifying in detail the further technical steps, the content and objective of each step, the corresponding costs and the responsibilities for each development step".

Since the early summer of 2011, when the European Parliament initially raised the possibility of placing SIS II appropriations into the reserve, the Commission has acted in full transparency, providing full details of contractual and financial matters related to the SIS II project and responding to specific questions placed by the Parliament.

- As a follow-up to the hearing at the LIBE (Civil Liberties, Justice and Home Affairs) Committee at the beginning of July 2012, Commissioner Malmström sent a letter to the European Parliament at the end of July 2012, informing the European Parliament about the latest developments and confirming the successful completion of the Milestone 2 test which was finally acknowledged by the General Affairs Council on 24 July 2012.
- During a technical briefing with the relevant rapporteurs of the European Parliament on 17 July 2012, the Commission provided detailed information on the contractual and financial matters and progress with the project. Exhaustive tables describing all commitments and payments for each contract since the start of the project were also distributed on that occasion.

In addition to this, the Commission very regularly informs the European Parliament on the state of play of the SIS II project:

- Twice a year, the Commission transmits a progress report on SIS II to the EP and the Council which
 describes the technical developments that occurred during the reporting period, together with a
 detailed financial state of play of the project.
- Furthermore, the Commissioner regularly informs the Chairman of the LIBE on any SIS II-related outcome of Justice and Home Affairs Councils, and has on several occasions addressed SIS II matters in European Parliament plenary sessions. Additional updates on the general status of SIS II have also been provided in the framework of the discussions in LIBE concerning amendments to the legal instruments for migration from SIS1+ to SIS II. The latest of those updates took place on Monday 3 September 2012.
- The minutes of each SIS-VIS (Visa Information System) committee, which contain extensive information on the latest state of play with the project, are circulated to the European Parliament.

In conclusion, the Commission has provided, in complete transparency, all of the information requested by the European Parliament and considers that the conditions for the release of SIS II appropriations from the reserve have been fully met and therefore requests the release of this reserve, which comprises the amounts of EUR 5 180 000 in commitment appropriations and EUR 6 131 700 in payment appropriations.
