<u>The Council</u> took note of the comments made by delegations and the Commission on the simplification of the CAP. The Council invited the Commission and the Member States to pursue the simplification process further both at EU and national level.

In this respect, the Council also invited the Commission and the Member States to assess on a regular basis, in the appropriate framework, the progress made on simplification of the CAP reform legislation, and to report back to the Council during the next Presidency, before the adoption of the reform proposals.
