Declaration by the Netherlands pursuant to Article 14(3) of Framework Decision 2008/947/JHA

The Netherlands hereby declares that it will refuse to assume responsibility for the subsequent decisions referred to in Article 14(1)(b) and (c) of the Framework Decision:

- (a) in cases where the judgment imposes an alternative sanction within the meaning of Article 2(4) of the Framework Decision and does not contain a custodial sentence or measure involving deprivation of liberty to be enforced in case of non-compliance with the penalty concerned;
- (b) in cases where the judgment relates to a conditional sentence within the meaning of Article 2(3) of the Framework Decision.
