Upon the adoption of this item, <u>the Committee</u> agreed to enter into the minutes of its meeting the following Statement by the Netherlands and the United Kingdom:

"The Netherlands and the United Kingdom recall the European Council Conclusions of 17 June 2010 which stated that "negotiations will be aimed at Iceland integrally adopting the EU *acquis* and ensuring its full implementation and enforcement, addressing existing obligations such as those identified by the EFTA Surveillance Authority under the EEA Agreement, and other areas of weakness identified in the Commission's Opinion, including in the area of financial services". This language was included in the General EU Position for the Intergovernmental Conference of 27 July 2010 on the Accession of Iceland.

In this context, the Netherlands and the United Kingdom understand that the benchmark "Iceland demonstrates progress in addressing existing obligations under the EEA Agreement" will be assessed in light of the EFTA Court case E-16/11 EFTA Surveillance Authority vs the Republic of Iceland. Iceland is expected to take concrete and irreversible steps to remedy any breach of EEA law identified by the EFTA Court. This understanding will guide our consideration of the Commission's closing benchmark assessment report for this chapter."

# 41. Interinstitutional cooperation within the framework of the "Compact for Growth and Jobs"

<u>The Committee</u> discussed the revised version of the text on the Inter-institutional cooperation within the framework of the 'Compact for Growth and Jobs'. In the light of this discussion and further written comments, a final revised version would be put under silence procedure.

## 42. EU-Canada Strategic Partnership Agreement (SPA)

The EEAS and the Commission reported on the state of play of the negotiations. More than 90% of the text has been already agreed, however, the political clauses remain the outstanding issue, namely, immediacy of suspensive action and linkage to CETA.

The EEAS, considering that the end of the negotiations is quickly approaching and in view of the forthcoming visit of HR Ashton to Ottawa on 1 October, invited <u>the Committee</u> to reconfirm the 2009 Common Approach on the use of political clauses in connection with this Agreement.

<u>The Committee</u> took note of the information provided by the EEAS on the state of play of the negotiations on the EU-Canada Strategic Partnership Agreement, in particular regarding the "political clauses".

<u>The Committee</u> reconfirmed the essential elements of the EU common approach to the "political clauses" agreed in 2009, which is to be applied to this Agreement and invited the HR to convey this message during her visit to Ottawa.
