Subject : - Proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund in accordance with point 28 of the Interinstitutional Agreement of 17 May 2006 between the European Parliament, the Council and the Commission on budgetary discipline and sound financial management (application EGF/2012/002 DE/manroland from Germany)
- Proposal for transfer of appropriations No DEC 27/2012 within Section III - Commission - of the general budget for 2012

1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 13784/12 FIN 655 SOC 746, accompanied by the corresponding proposal for transfer of appropriations No DEC27/2012, as recorded in document 13785/12 FIN 656.

2. The proposal aims at mobilising an amount of EUR 5 352 944 under the EGF to meet an application from Germany to deploy the Fund in connection with redundancies in the printing machinery producer manroland. The company has lost important market shares and suffered from sharp decline in sales due to the raising competition from the lower-cost non-EU producers in the context of major structural changes in the world trade patterns.

The purpose of the proposed transfer of appropriations is to move this amount in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
4. The Budget Committee examined both proposals at its meeting on 25 September 2012.
5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the Decision on the mobilisation of the EGF, as set out in document 13784/12;
 - approve the proposed transfer of appropriations, as set out in document 13785/12;
 - approve the annexed draft letter to the European Parliament and to the Commission to that effect.
