- Proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund in accordance with point 28 of the Interinstitutional Agreement of 17 May 2006 between the European Parliament, the Council and the Commission on budgetary discipline and sound financial management (application EGF/2012/003 DK/Vestas from Denmark)
- Proposal for transfer of appropriations No DEC 28/2012 within Section III Commission of the general budget for 2012
- 1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 13786/12 FIN 657 SOC 747, accompanied by the corresponding proposal for transfer of appropriations No DEC 28/2012, as recorded in document 13787/12 FIN 658.

2. The proposal aims at mobilising an amount of EUR 7 488 000 under the EGF to meet an application from Denmark to deploy the Fund in connection with redundancies in the wind turbine manufacturing industry. The Danish major wind turbine producer, Vestas Group, has lost important market shares due to the raising competition from the lower-cost non-EU producers in the context of major structural changes in the world trade patterns.

The purpose of the proposed transfer of appropriations is to move this amount in commitment appropriations from Article 40 02 43 (Reserve for the European Globalisation Adjustment *Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

- 3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
- 4. The <u>Budget Committee</u> examined both proposals at its meeting on 25 September 2012.
- 5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the Decision on the mobilisation of the EGF, as set out in document 13786/12;
 - approve the proposed transfer of appropriations, as set out in document 13787/12;
 - approve the annexed draft letter to the European Parliament and to the Commission to that effect.
