"The Commission considers that the documents transmitted by the European Union in addition to other parties to the ICAO -12th Air Navigation Conference (ANC/12) in Montréal on 19-30 November 2012 should be prefaced "Presented by the European Commission on behalf of the European Union and its Member States; by the other Members States of the European Civil Aviation Conference and by EUROCONTROL".

The Commission as a matter of compromise is ready to accept the following formulation according to which the document is prefaced "Presented by the European Union and its Member States; by the other Members States of the European Civil Aviation Conference and by EUROCONTROL", as this formulation was applied recently for the ICAO High Level Security Conference with the support of COREPER and ECAC.

The Commission objects to the following formula agreed by the Council "Presented by the Presidency of the European Union on behalf of the European Union and its Member States; and by the other States Members of the European Civil Aviation Conference; and by the Member States of EUROCONTROL". The Commission considers that this formula is contrary to the rules on external representation laid down in the Treaties, according to which the rotating Presidency of the Council of the European Union is not entitled to represent the European Union externally."

Following an almost full table round, where opposing views were expressed e.g. on the eligibility to funding of projects exempted under the internal energy market legislation, on a more formal coordination between the High Level Steering Groups, on being more ambitious on interconnections or regarding the timeframe for permit granting, <u>the Committee</u> reached agreement on a general mandate for the first informal trilogue on 15 October 2012 on the basis of the 3rd and 4th column of the document 14113/12. Besides the Chair noted suggestions made, which could be taken up with a view to future trilogues, and committed to finding a solution to the concerns linked to the deadline set in Art. 9(1).

Under 'Any other business', IT MFA could raise the issue of the ruling of the Indian Supreme Court with regard to two Italian soldiers, scheduled for 10 October 2012.

During <u>lunch</u> Ministers will discuss the <u>Eastern Partnership</u>. The main focus will be on the aftermath of the elections in Belarus. Other topics: the aftermath of the parliamentary elections in Georgia and elections in Ukraine.

On the eve of the FAC Ministers will have an <u>informal dinner with the Russian MFA Lavrov</u>. The main topics to be discussed are Syria and Iran. MFA Lavrov also expressed a wish for a general discussion on the EU-Russia relations.
