The Polish delegation wishes to inform delegations that Poland recognises the following travel documents:

ISRAEL

"Travel document in lieu of national passport"

An "X" should be inserted in row 11 for the "Travel document in lieu of national passport", in the column "PL".

<u>PERU</u>

"Special passport"

An "X" should be inserted in row 4, in the column "PL".

<u>GEORGIA</u>

"Refugee's travel document"

An "X" should be inserted in row 8, in the column "PL".

AUSTRALIA

"Refugee's travel document"

An "X" should be inserted in row 8, in the column "PL".

<u>EGYPT</u>

"Travel document for Palestinian refugees"

An "X" should be inserted in row 11 for the "Travel document for Palestinian refugees" in the column "PL".

<u>TURKEY</u>

"Temporary passport"

A new row "Temporary passport" should be added under number 11 and an "X" should be inserted in the column "PL".

ARGENTINA

- "Consular passport (category C)"

An "X" should be inserted in row 11 for "Consular passport category C" in the column "PL" with the following footnote "Treated as an ordinary passport".

- "Pasaporte de emergencia"

A new row "Pasaporte de emergencia" should be added under number 11 and an "X" should be inserted in the column "PL" with the following footnote: "Recognized for exit to return to Argentina".

<u>CYPRUS</u>

"Ordinary passport"

An "X" should be inserted in row 1, in the column "PL".

<u>NEPAL</u>

"Travel document (book form)"

An "X" should be inserted in row 11 for "Travel document (book form)" in the column "PL".

TUNISIA

- "Special passport"

An "X" should be inserted in row 4, in the column "PL".

- "Refugee's travel document"

An "X" should be inserted in row 8, in the column "PL".

SOUTH KOREA

"Passport (single – use passport)"

A new row "Passport (single-use passport)" should be added under number 11 and an "X" should be inserted in the column "PL".

SOUTH SUDAN

- "Ordinary passport"

An "X" should be inserted in row 1, in the column "PL".

- "Diplomatic passport"

An "X" should be inserted in row 2, in the column "PL".

- "Service passport"

An "X" should be inserted in row 3, in the column "PL" with the following footnote: "Recognised under the name official passport.".

- "Special passport"

An "X" should be inserted in row 4, in the column "PL".

HAITI

"Service passport"

An "X" should be inserted in row 3, in the column "PL" with the following footnote: "Recognised under the name official passport.".

ECUADOR

"Special passport"

An "X" should be inserted in row 4, in the column "PL".

<u>ROMANIA</u>

"Ordinary passport"

An "X" should be inserted in row 1, in the column "PL".

LEBANON

- "Travel document for Palestinian refugees" is recognised by Poland.

An "X" should be inserted in row 11 for "Travel document for Palestinian refugees" in the column "PL".

- Laissez –passer is not recognised by Poland.

An "O" should be inserted in row 11 for "Laissez -passer" in the column "PL".

BOSNIA AND HERZEGOVINA

"Putni List (travelling certificate)" is not recognised by Poland.

An "0" should be inserted in row 11 for "Putni List (travelling certificate)" in the column "PL".
