"Bulgaria fully recognises the importance of establishing a common legislative framework with harmonized rules for marketing and use of explosive precursors, which would also aim at strengthening the level of public security and reducing the risk of terrorist attacks throughout the Union.

Bulgaria will therefore support the adoption of the Regulation.

However, we would like to express our regrets that the proposed Regulation does not fully achieve its goals.

Bulgaria believes that the aim of the Regulation both as regards the functioning of the Internal market and the security issues, could best be achieved with a simpler regime.

Bulgaria therefore considers that the option which would cause least administrative burden would be not to derogate from the EU-wide restrictions at all."

Romania/Spain agrees with the decision on mandating the Commission to negotiate a framework for the participation of Kosovo* to the EU programmes given its concern for the stability and the prosperity of the Western Balkans.

Romania's/Spain's participation to the adoption of the aforementioned decision refers solely to the act of empowering the European Commission to conduct these negotiations with the single purpose to allow Kosovo's participation to EU programmes, does not concern any future steps after the conclusion of these negotiations and cannot be interpreted as a change of Romania's/Spain's position with regard to the status of Kosovo.

* This designation is without prejudice to positions on status, and is in line with UNSC 1244 and the ICJ Opinion on the Kosovo Declaration of Independence.

The Committee confirmed agreement with entering into negotiations with the EP at first reading on the basis of the draft mandate contained in the Annex to document 14242/12, including the revisions suggested on the basis of the work carried out by the Working Group on 8 October 2012. The Committee did not object to the Presidency's recommendation to change the title of the 3rd and 4th columns to 'Council's consolidated text' and 'Possible compromise text' respectively.

A number of points were raised by Member States during the discussion, namely on indicative national allocations, co-financing rates, Overseas Countries and Territories (OCTs), VAT and staff costs. Other issues were also raised.

Following the 'tour de table', the <u>Presidency</u> decided not to open the text but indicated that it will give the suggestions made due consideration as long as they do not affect the overall balance of the text. Some delegations expressed concerns and reservations on this approach.

The Committee was debriefed on the outcome of the trilogue of 9 October 2012.

- At the <u>breakfast</u> Ministers were <u>debriefed from the Eurogroup</u> the day before. They also had an exchange of views on the economic situation.
- Regarding the <u>format of the future breakfast meetings</u>, the Ministers agreed to keep the 1+1 format, where there will be the Eurogroup debrief and the discussion on the economic situation only. If there is a need for other discussions, the Presidency will organise an informal session in 1+2 format.
- The informal session after the breakfast was on the follow-up to the June 2012 European Council. Ministers had an exchange of views on the <u>roadmap for achieving</u> genuine Monetary Union. There was a rich debate where the focus was mainly on the institutional aspects of EMU as well as on the banking union.

The ECOFIN President announced that he would send in his own capacity a letter to the GAC President, copying the European Council President, reflecting the ECOFIN discussion.

- At the Council itself, Ministers were first updated on the state of play as regards the <u>Financial Transaction Tax</u> issue. There were seven letters and four oral indications in favour of enhanced cooperation. The Commission indicated that they would follow up in November. The Presidency said they would put this item on the November ECOFIN.
- After receiving an update on the state of play regarding the revised capital requirements rules (CRD IV), Ministers confirmed their commitment to agree on these rules as soon as possible.
- The Council was debriefed on the <u>Informal ECOFIN</u> meeting in Nicosia, with a focus on the state of play on the Commission proposals on Banking Supervision. The Presidency committed to work intensively on the supervision file.
- The Council then had a discussion on the lessons learnt from the 2012 European semester, including possible improvements for 2013. The Presidency indicated that they would take the comments into account when preparing the synthesis report.
- The Council adopted a Recommendation extending the deadline for correcting the excessive deficit in Portugal by one year, and updated the Implementing Decision granting financial assistance to <u>Portugal</u>.
- Ministers were then debriefed on the <u>G20</u> Finance Deputies. The Council mandated the EFC to endorse the final Terms of reference.
- Finally, Ministers had an exchange of views on the upcoming IMF and WB annual meetings in Tokyo and endorsed the draft IMFC Statement.
