Draft Council conclusions on Industrial Policy Communication update: A Stronger European Industry for Growth and Economic Recovery

THE COUNCIL OF THE EUROPEAN UNION,

RECALLING:

The European Council conclusions of 18/19 October 2012¹ which acknowledge the need to enhance the competitiveness of industry as stated in the Commission communication on the update of the EU industrial policy stressing the importance of developing an integrated approach in order to strengthen industrial competitiveness to underpin growth and jobs, whilst improving energy and resource efficiency;

The European Council conclusions of 23 October 2011², which identified a number of key priorities for economic policy that need to be pursued in order to achieve smart, sustainable, inclusive and green growth, and its commitment to work with the Commission to ensure that all actions at the European Union level fully support economic growth and job creation;

The Council conclusions of 5 December 2011³ on the industrial policy flagship initiative reinforcing implementation of industrial policy across the EU;

Industrial Policy Communication update: A Stronger European Industry for Growth and Economic Recovery,

THE COUNCIL OF THE EUROPEAN UNION agrees on the following:

21. UNDERLINES the importance of <u>the EU's</u> industryial competitiveness and its world leadership in many industrial sectors, and RECOGNISES the major contribution that EU <u>manufacturing</u> industryies can make to recover from the economic crisis, and <u>alongside</u> with services sectors, to strengthening the longer-term competitiveness of the EU economy and to anticipate future evolution;

- 42. WELCOMES the Communication from the Commission entitled "Industrial Policy Communication update: A Stronger European Industry for Growth and Economic Recovery" that emphasises the <u>crucial</u> importance of strengthening industrial competitiveness to underpin growth and jobs and to <u>enable <u>facilitate</u> the transition to a low emission and resource-efficient economy, in order to <u>fulfil contribute to</u> the Europe 2020 <u>strategy goals</u>;</u>
- 3. RECOGNISES the contribution of <u>all industrial sectors</u>, <u>including energy-intensive</u> <u>industries</u>, <u>can make in the EU competitiveness and WELCOMES the recently adopted</u> <u>communications on</u> Construction¹⁰, Security¹¹, <u>as well as</u> Cultural and Creative sectors¹² and [CARS21], and for the afore mentioned sectoral initiatives:
 - INVITES the Commission and Member States to implement the Action Plan proposed in the "Construction 2020" Communication, in particular for stimulating investment and innovation in the sustainable renovation of buildings and for improving skills and qualifications;
 - EMPHASISES the need to create a true internal market for security products and technologies with a view to enhancing the competitiveness of the sector and INVITES Member States, in close cooperation with the Commission, to ensure the efficient implementation of the actions laid out in the respective Communication;
 - INVITES the Commission and Member States to stimulate cross-fertilisation between designers and manufacturers and to develop the right regulatory environment as a strategic contribution to the intangible economy;

Member States to identify and propose measures adapted for each of those sectors in order to
boost their high innovation and productivity growth potential;

- 54. EMPHASISES the urgent need for new investments in innovation, including non-technological innovation and eco-innovation, new-energy and resource-efficient technologies in order to best prepare EU industry for the so-called "third industrial revolution" era and reap the opportunities for future sustainable growth; WELCOMES the Commission's ambition to reverse the current downward trend of the contribution of industry to EU GDP, and TAKES NOTE of its stated objective of encouraging an increase of industry's share to 20 % of GDP by 2020; target to raise the share of industry, including SMEs, contribution to GDP from the current level of around 16% to as much as 20% in 2020;
- 65. UNDERLINES the need to translate EU research into industrial advantage to cover the entire value-chain, and to focus on the gap between research results, innovation, and manufacturing and commercialisation in Europe, especially for through Key Enabling Technologies;
 STRESSES the importance of facilitating the involvement of businesses in Horizon 2020; and to develop further demand side approaches and initiatives; STRESSES the role of world-class clusters and strong EU inter-clustering networking activities as key components of the EU industrial policy competitiveness, drivers of innovation, technology diffusion and knowledge spillovers; TAKES NOTES of the six priority lines actions selected in order designed to stimulate new investments, speed up the adoption of innovative technologies, and boost resource efficiency; INVITES the Commission together with Member States and Regions to promote cooperation of all among the different stakeholders to deliver the industrial policy agenda and help the uptake of new technologies and investments;

i) Markets for advanced manufacturing technologies for clean production

ii) Markets for key enabling technologies

iii) Bio-based product markets

iv) Sustainable industrial policy, construction and raw materials

v) Clean vehicles and vessels

vi) Smart grids

- 76. RECOGNISES the investment/business opportunities that the internal market offers, and UNDERLINES that regulatory environment need to be clear and consistent so as to provide EU businesses with the legal certainty they need to market their products and services across borders as they do in their domestic markets, in order to exploit all the opportunities of the Single Market; ACKNOWLEDGES the need to create a better regulatory environment for EU companies; WELCOMES the Commission's intention to take measures in order to strengthen the Internal Market by all available means; , notably the entrepreneurship action plan, the review of the Internal Market for goods, the Digital Agenda for Europe, the increased use of competitiveness proofing, the future high-level group on Business Related Services.
- 4.7. WELCOMES the Commission's intention to carry out pilot "horizontal sectoral" fitness checks starting with petroleum and aluminium sectors; and INVITES the Commission to take forward further sectoral initiatives together with Member States, and businesses and other stakeholders to minimize regulatory burden and to boost their high innovation and productivity growth potential of EU Industry, especially and SMEs; EMPHASISES that competitiveness testing proofing has to play a prominent role to ensure the consistency of rules and to prevent further unnecessary red tape and compliance costs; the cost of crossing the borders in the IM, by having to comply with different national legislation, should also be taken into account;
- 8. EMPHASISES the importance of Intellectual property rights for innovative companies; as well as of the unitary patent and of a unified patent litigation system in the EU; TAKES NOTE of the Commission's intention to examine possible options in the domain of IPR and business secrets in order to increase transparency and deter misuses improve in the treatment of IPR in standardisation;

- 9. RECOGNISES the difficulties European businesses, especially SMEs, innovative startups, and in particular in cooperative projects covering parts of value chain or clusters face when trying to that access to finance and capital markets; constitutes a major problem for European businesses, especially SMEs and innovative start ups, and IDENTIFIES that investment in the adoption of innovative technologies and solutions is crucial for the recovery and growth of EU industry; INVITES the Commission to cooperate with the EIB and EIF in order to ensure the implementation and coherence of the financial instruments in the Horizon 2020 and COSME programmes and to reflect on how to facilitate and diversify access to finance for SMEs and innovative start-ups; EMPHASISES the strong role of Cohesion and Structural Funds, also for the support of all enterprises, and CALLS FOR the Member States and Regions to ensure their effective use;
- 10. RECOGNISES that human capital and an appropriate pool of skills <u>and competences</u> are central to the success of a modern industrial policy; therefore INVITES the Commission to encourage actions to enhance job creation and education in <u>new desirable</u> skills, and INVITES Member States to <u>develop carry out</u> job creation policies, <u>promote lifelong learning</u>, and to set up agendas for education and training in competitiveness, <u>including entrepreneurial</u> skills, <u>and to develop the dual system of vocational training in cooperation with businesses</u>;
- 11. INVITES the Commission together with Member States to identify and propose measures and strategies with European added value adapted to largely different national situations in order to boost the high innovation and productivity growth potential of EU industry; INVITES the Commission, Member States, and Regions in the light of the current economic challenges to apply a broad and coherent industrial policy approach for competitiveness, sustainable growth and high-value jobs, and to better coordinate exploit synergies between all relevant EU policies; such as SMEs, cohesion, trade, research, environmental and competition policy; including the EU frameworks on State aid;

- 142. ENCOURAGES, where appropriate, further progress between the Commission, Member States, and Regions in their cooperation towards a better EU governance in order for industry to play a major role in the EU's economic growth and to keep pace with EU's main international competitors;
- 123. STRONGLY SUPPORTS the Commission efforts to further embedded industrial policy within the European Semester process, and INVITES the High Level Group on Competitiveness and Growth to assist the Council in annually assessing progress made by Member States and at EU level in the implementation of relevant structural reforms and on the effectiveness of industrial policy measures. to strengthen competitiveness, ensuring that it fits into the European Semester.
