The SCA took note of the Presidency's intention to distribute a set of legal adjustments to the draft Regulation reflecting the outcome of recent discussions in the SCA or in the Working Party, including on the accession of Croatia and on the Council's position on Article 43(3) TFEU.

inclusion of the provisions on buying-in at a fixed price or tendering in public intervention and on the understanding that the draft Regulation would be adjusted, as appropriate, in the light of future discussions on CAP reform.

4. **Proposal for a Regulation of the European Parliament and of the Council establishing rules for direct payments to farmers under support schemes within the framework of the common agricultural policy**

The SCA considered a set of suggested Presidency amendments as set out in document 15625/12.

The SCA noted the Presidency's summary, the main elements of which were as follows:

- The Presidency's suggested amendments were broadly supported as a step in the right direction although several delegations reserved their position pending the political decision on the mandatory or voluntary nature of the scheme.
  - Some delegations expressed concerns about the suggested method for reallocation of unused funds through the national reserve and several others requested a general mechanism in the Regulation to deal with any unused funds.
  - Delegations' other comments and scrutiny reserves were noted, as well as the comments of the Commission representative.
- Accession of Croatia
    - *Information on the revised Presidency text*<sup>1</sup>

The SCA took note of the Presidency's intention to distribute a set of legal adjustments to the draft Regulation to take account of the accession of Croatia and to incorporate a number of further legal-linguistic changes.

The SCA further took note of the Presidency invitation to delegations to submit written comments, as appropriate, to the Council Secretariat by 9 November 2012, close of business.
