#### 44. Preparation of the Council meeting (Foreign Affairs) on 19 November 2012

- Other items in connection with the Council meeting

<u>The Committee</u> was briefed by ESG Pierre Vimont on the above referred item. Vimont confirmed that the Council meeting will consist of two parts: Defence Ministers in the morning and Foreign Ministers in the afternoon, with a joint Defence-Foreign Ministers lunch in between.

The Defence Ministers' part will start at 9H30 in EDA Steering Board format, to discuss Pooling and Sharing, and Synergies with wider EU policies. The Defence Ministers' segment will continue in the FAC Defence format and with NATO SG in attendance, at 11H00, to discuss two topics, Task Force Defence, at the presence of Commissioner Barnier, and state of play of CSDP operations.

The joint Defence-Foreign Ministers' lunch will start at 12H30, with two main topics: Mali, and an orientation discussion on possible Defence topics for the December European Council.

The Foreign Ministers' part will start after lunch. The main items for discussion will be: Africa (Mali, DRC); Southern Neighbourhood (Syria, Egypt, Libya); MEPP; Ukraine; Cuba. Other possible items for discussion are US and Russia.

In the margins of the FAC, the EU-Tunisia Association Council will take place.

One delegation highlighted the importance to keep on the agenda the item on the US, in light of the Presidential elections. Two delegations underlined the need to prepare adequately the December Summit with Russia, through a discussion at Foreign Ministers' level. Two delegations requested to add to the agenda a discussion item on Lebanon.

Pierre Vimont took note of all comments and requests. He noted that, in particular for Russia, Lebanon and Ukraine the main point was to decide the most appropriate timing for discussions and FAC conclusions.

The Chair informed <u>the Committee</u> in detail on the Presidency's intention for the follow-up of all matters dealt with by the Council that so required. He informed as well <u>the Committee</u> on the content of the discussions held during the lunches of the Ministers of Interior and Justice.

The Commission informed <u>the Committee</u> on the upcoming Ministerial meeting with the Western Balkans and of its intention to obtain concrete commitments from the Western Balkans countries on various issues.

Several delegations asked the Presidency to convene a JHA Counsellors meeting to clarify the positions of the Commission and of delegations expressed at the Council in view of incoming trilogues with the European Parliament. The presidency agreed to their request.

## 48. Presentation of the agenda of the Council meeting (Foreign Affairs/Trade) on 29 November 2012

The Presidency informed <u>the Committee</u> about the provisional agenda of the Foreign Affairs Council (Trade) of 29 November 2012 (Legislative deliberations: Omnibus, Financial responsibility for investor-state dispute settlement; Non-legislative deliberations: Japan, Canada, Singapore, Southern Mediterranean; lunch items: Russia, China).

The Presidency took note of delegations' comments, concluding that <u>the Committee</u> had endorsed the provisional agenda of the above-mentioned Council meeting and that <u>the Committee</u> would revert to the preparations for that meeting on 14-15 November 2012.

During the discussion on MFF, FR made the following statement on Mayotte:

"La France rappelle que Mayotte deviendra région ultrapériphérique de l'Union européenne à compter du 1<sup>er</sup> janvier 2014, conformément à la décision du Conseil européen du 11 juillet 2011.

Dans ce contexte, la France souligne la nécessité de prendre en compte Mayotte dans la négociation en cours sur le prochain cadre financier pluriannuel 2014-2020, afin de garantir que ce territoire bénéficie, à compter du 1<sup>er</sup> janvier 2014, de l'ensemble des instruments financiers de l'Union Européenne auxquels elle peut prétendre en tant que partie intégrante et région ultrapériphérique de l'Union européenne."
