1. On 6 June 2010, the Council of the European Union decided to conclude consultations with the Republic of Madagascar and to take appropriate measures under Article 96 of the ACP-EU Partnership Agreement by means of Council Decision 2010/371/EU¹. This Decision was amended and its period of application was prolonged, lastly by means of Council Decision 2011/808/EU of 5 December 2011², which will expire on 6 December 2012.

- 2. On 13 November 2012, the Commission forwarded to the Council a proposal for a Council Decision extending the application period of Decision 2010/371/EU, with a draft letter to the Interim President of the Republic of Madagascar attached thereto³.
- 3. The ACP Working Party discussed the abovementioned proposal and agreed on the text of the draft Council Decision on 15 November 2012.
- 4. In accordance with Article 3 of the Annex to the Internal Agreement for the implementation of the ACP-EC Partnership Agreement⁴, the Decision should be adopted by the Council acting by qualified majority.
- 5. The Permanent Representatives Committee is accordingly invited to recommend that the Council as an "A" item on its agenda:
 - adopt the Decision, as set out in document 16208/12 ACP 224 COAFR 362 PESC 1388 RELEX 1039 OC 643, after finalisation by the legal/linguistic experts;
 - agree to send the letter attached to that Decision to the Interim President of the Republic of Madagascar;
 - decide to publish the Decision and the attached letter in the Official Journal of the European Union.
