1. The Commission submitted to the Council on 10 November 2011 a proposal for Council Decision on the signing of the above-mentioned Agreement¹, as well as a proposal for a Council Decision on its conclusion ².

- 2. The Council Decision on the signing of the Agreement was adopted by the Council on 14 December 2011¹. At the same time and in accordance with Article 218(6)(a)(v) TFEU, the Council decided to forward draft Council Decision on the conclusion of the Agreement, as finalised by the legal/linguistic experts and set out in documents 16775/1/11 REV 1 and 16776/ + COR 1 + COR 2, to the European Parliament for its consent, with a view to preparing for the future conclusion of the Agreement.
- 3. Following the adoption of the Council Decision, the Agreement was signed on 16 December 2011 with the Russian Federation.
- 4. The European Parliament provided its consent to the conclusion of the Agreement on 21 November 2012.
- 5. The draft Council Decision on the conclusion of the Agreement was endorsed by the Trade Policy Committee (Deputies) on 23 November 2012.
- 6. The Permanent Representatives Committee is therefore invited to recommend that the Council adopts, as an "A" item on the agenda of one of its forthcoming meetings, draft Council Decision on the conclusion of the Agreement, as finalised by legal/linguistic experts and set out in documents 16775/1/11 REV 1 and 16776/11 + COR 1 + COR 2.
