	Maria WELSKOP-DEFFAA, who has resigned

- 1. The <u>General Secretariat of the Council</u> has been informed of the resignation of Ms Eva Maria WELSKOP-DEFFAA as member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Germany).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006<sup>1</sup> provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

Having regard to Regulation (EC) No 1922/2006 of 20 December 2006 establishing the European Institute for Gender Equality<sup>2</sup>, and in particular Article 10 thereof,

#### Whereas:

- (1) By its Decision of 18 May 2010<sup>3</sup> the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2013.
