Subject: Proposal for transfer of appropriations No DEC 48/2012 within Section III -

Commission - of the general budget for 2012

The Commission submitted to the Council proposal for transfer of appropriations
 No DEC 48/2012 within Section III - Commission - of the general budget for 2012.

The purpose of this proposal is to transfer an amount of EUR 2 567 480 in commitment appropriations (c/a) and an amount of EUR 378 385 in payment appropriations (p/a) from Article 40 02 41 (*Reserves for financial interventions - Differentiated appropriations*) to Article 11 03 01 (*International fisheries agreements*), as recorded in document 16552/12 FIN 885.

- 2. The mobilisation of the reserve line is needed in order to enable the Commission to cover:
 - the financial contribution (EUR 1 325 000 in c/a) provided for in the fisheries partnership agreement between the European Union and the Republic of Kiribati, following the adoption by the Council of a Decision¹ on the signing, on behalf of the European Union, and provisional application of the relevant Protocol;
 - the compensation (EUR 1 242 480 in c/a and 928 400 in p/a) to the Republic of Gabon and to the Republic of Kiribati for additional catches in 2011. Taking into account p/a still available on the operational line, the net increase in p/a is EUR 378 385.
- 3. <u>The Budget Committee</u> examined this proposal for a transfer at its meeting on 29 November 2012.
- 4. Following that examination, <u>the Budget Committee</u> agreed, by qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in ANNEX to that effect.
