Subject: Proposal for transfer of appropriations No DEC47/2012 within Section III -

Commission - of the general budget for 2012

1. The Commission submitted to the Council proposal for a transfer of appropriations No DEC47/2012 within Section III - Commission - of the general budget for 2012.

The purpose of this proposal is to reinforce Article 23 02 01 (*Humanitarian aid*) with EUR 50 million in commitment appropriations through a transfer from:

- Article 01 03 02 (Macroeconomic assistance) an amount of EUR 33 million,
- Article 05 06 01 (International agricultural agreements) an amount of EUR 2 million,
- Item 19 06 01 01 (*Crisis response and preparedness Instrument for Stability*) an amount of EUR 15 million.

Moreover, it is proposed to transfer an amount of EUR 15.7 million in payment appropriations from Article 40 02 42 (*Emergency aid reserve*) to Article 23 02 01 (*Humanitarian aid*), as recorded in document 16765/12 FIN 902.

- 2. The transfer is being proposed in order to provide humanitarian assistance for the following crises: Sudan/South Sudan with an amount of EUR 30 million and Mali with an amount of EUR 20 million.
- 3. The Budget Committee examined the proposal for a transfer at its meeting on 29 November 2012.
- 4. In accordance with the provisions of Point 25 of the Interinstitutional Agreement of 17 May 2006, a simplified trilogue was held on the Commission proposal.
- 5. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in ANNEX to that effect.
