THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 207 and 212, in conjunction with Article 218(6)(a), thereof,

Having regard to the Act of Accession of the Republic of Croatia, and in particular Article 6(2) thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament,

Whereas:

- (1) Under the terms of Article 6(2) of the Act of Accession, Croatia's accession to the Framework Agreement between the European Union and its Member States, on the one part, and the Republic of Korea, on the other part<sup>1</sup>, is to be agreed by means of a Protocol to the Agreement. A simplified procedure is to apply whereby the Protocol is to be concluded by the Council, acting unanimously on behalf of the Member States, and by the third countries concerned.
- (2) On 14 September 2012, the Council authorised the Commission to open negotiations with the third countries concerned. The negotiations with the Republic of Korea were successfully concluded and the Protocol was signed on behalf of the Union and its Member States in [...] on [...] <sup>2\*</sup>.
- (3) The Protocol should therefore be approved,

*Article 1*

The Protocol to the Framework Agreement between the European Union and its Member States, on the one part, and the Republic of Korea, on the other part, to take account of the accession of the Republic of Croatia to the European Union is hereby approved on behalf of the Union and its Member States.<sup>1</sup>

*Article 2*

The President of the Council shall , on behalf of the Union and its Member States, give the notification provided for in Article 4(1) of the Protocol.

*Article 3*

This Decision shall enter into force on the date of its adoption.
