The Committee reached agreement on the text of the Decision authorising enhanced cooperation and the two Regulations implementing it.

DK announced that it will abstain on the Council Decision, since the subject matter of the enhanced cooperation falls within the scope of Protocol 22.

The Council Legal Service confirmed that the adoption of the two Regulations would not affect the application of existing bilateral agreements between non participating Member States and participating Member States which concern the same matters.

UK presented the following statement:

Statement by UK

"The United Kingdom notes, for the purposes of both COREPER and Council, its consistent position across all legislative files that references to the Charter of Fundamental Rights in operative articles, such as those in the two proposed Council Regulations implementing enhanced cooperation, are unnecessary, because all EU legislation must in any event respect the rights and observe the principles reflected in the Charter.

In the context of the Commission's agenda for better law making, the United Kingdom emphasises the importance of the European Union adopting best practice in legal drafting and clarity, and considers that it is out of step with such practice to duplicate existing law in this way. For the sake of completeness, the United Kingdom also emphasises that substantive family law matters such as marriage, registered partnerships, succession and divorce are, and must remain, the competence of Member States."

Statement by UK

"The United Kingdom fully supports the aims and objectives of the proposal for a Directive laying down technical requirements for inland waterway vessels, and believes that the proposal will lead to significant improvements in safety.

However, the United Kingdom believes that the final adoption of a delegated act is disproportionate and that an implementing act would be more appropriate given that the issue at stake is the implementation of international standards, and not the supplementation or amendment of a non-essential part of the legislation. Consequently, the United Kingdom is abstaining against the Directive laying down technical requirements for inland waterway vessels."
