Legislative deliberations

- Draft Regulation of the European Parliament and of the Council amending Regulation (EU) No 575/2013 as regards exemptions for commodity dealers **(First reading)**
= Adoption of the legislative act
- Draft Regulation of the European Parliament and of the Council amending Regulation (EC) No 184/2005 on Community statistics concerning balance of payments, international trade in services and foreign direct investment as regards conferring of delegated and implementing powers upon the Commission for the adoption of certain measures **(First reading)**
= Adoption of the legislative act

- Draft Regulation of the European Parliament and of the Council on protection against dumped imports from countries not members of the European Union (codification) **(First reading)**
= Adoption of the legislative act
- Draft Regulation of the European Parliament and of the Council on protection against subsidised imports from countries not members of the European Union (codification) **(First reading)**

Non-legislative activities

- Draft Council Decision on the position to be adopted, on behalf of the European Union, in respect of an international instrument to be elaborated by the ICAO bodies and intended to lead to the implementation from 2020 of a single global market-based measure addressing emissions from international aviation
= Adoption
- Determination of equivalence pursuant to Article 8(3) of the Interinstitutional Agreement (IIA) between the European Parliament and the Council concerning the forwarding to and handling by the European Parliament of classified information held by the Council on matters other than those in the area of common foreign and security policy
- Draft Council Decision appointing a member, proposed by Malta, of the Committee of the Regions
= Adoption
- Draft Council Decision on the signing, on behalf of the European Union, of an Agreement between the United States of America and the European Union on the protection of personal information relating to the prevention, investigation, detection, and prosecution of criminal offenses
= Adoption
