Subject: Governing Board of the European Foundation for the Improvement of Living and Working Conditions
Appointment of Mr Thomas FISCHER, member for Germany, in place of Ms Marika HÖHN, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Marika HÖHN as member of the Governing Board of the above Foundation in the trade union representatives category (for Germany).
2. Under Article 6 of Regulation (EEC) No 1365/75, as amended by Regulation (EC) No 1111/2005, members and alternate members of the Governing Board are appointed by the Council.

3. In accordance with the usual procedure, the trade unions organisation ETUC has nominated the following candidate to replace the resigning member for the remainder of the current term of office, ending on 30 November 2016:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EEC) No 1365/75 of 26 May 1975 on the creation of a European Foundation for the Improvement of Living and Working Conditions¹, and in particular Article 6 thereof,

Whereas:

- (1) In its Decisions of 2 December 2013² and of 8 July 2014³, the Council appointed the members and alternate members of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions for the period ending on 30 November 2016.
- (2) A seat as member of the Governing Board of that Foundation in the trade union representatives category has fallen vacant as a result of the resignation of Ms Marika HÖHN.
