THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 1612/68 of 15 October 1968 on freedom of movement for workers within the Community<sup>1</sup>, and in particular Articles 26 and 27 thereof,

Whereas:

- (1) In its Decision of 4 October 2012<sup>2</sup> and 20 November 2012<sup>3</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2014.
- (2) A seat as alternate member in the trade unions' representatives category has fallen vacant as a result of the resignation of Mr Franz FRIEHS.
- (3) The Government of Austria has submitted a nomination for the vacant seat,
