Subject: Advisory Committee for the Coordination of Social Security Systems  
- Appointment of Ms Elin HEINVEE, alternate member for Estonia, in place of Ms Katerin PEÄRNBERG, who has resigned

---

1. The General Secretariat of the Council has been informed of the resignation of Ms Katerin PEÄRNBERG as alternate member of the above Committee in the government representatives category (for Estonia).
2. Under Article 75 of Regulation (EC) 883/2004 of 29 April 2004<sup>1</sup> which sets up the Advisory Committee for the Coordination of Social Security Systems, members and alternate members are appointed by the Council, whereas by the Council Decision of 13 October 2015<sup>2</sup>, the appointments are valid for a period of five years.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 883/2004 of the European Parliament and of the Council of 29 April 2004 on the coordination of social security systems<sup>3</sup>, and in particular Article 75 thereof,

Whereas:

- (1) In its Decision of 13 October 2015<sup>4</sup>, the Council appointed the members and alternate members of the Advisory Committee for the Coordination of Social Security Systems for the period ending on 19 October 2020.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Ms Katerin PEÄRNBERG.
- (3) The government of Estonia has nominated a candidate for the vacant seat,
