EXPLANATORY MEMORANDUM

A Framework Agreement on Comprehensive Partnership and Cooperation between the European Community and its Member States, of the one part, and the Republic of Indonesia, of the other part ('the Agreement') was signed on 9 November 2009 and entered into force on 1 May 2014.

The Agreement provides a legal framework covering issues from regular political dialogue to sectoral cooperation. It underlines the EU's determination to engage with Indonesia and to take bilateral relations to a higher level.

The Agreement strengthens cooperation across a wide spectrum of policy fields, including human rights, non-proliferation of weapons of mass destruction, combating terrorism, the fight against corruption and organised crime, trade, migration, environment, energy, climate change, transport, science and technology, employment and social affairs, education, agriculture, development assistance and culture, etc..

Pursuant to Article 41 of the Agreement, a Joint Committee was established, composed of representatives of both sides at the highest possible level. The Joint Committee is to ensure the proper functioning and implementation of the Agreement, set priorities in relation to the aims of the Agreement and resolve differences arising in its application or interpretation.

To assist the Joint Committee and facilitate expert-level discussions on some key areas falling within the scope of the Agreement, it is suggested that specialised working groups be established, on:

- (1) development cooperation;
- (2) trade and investment;
- (3) human rights dialogue;
- (4) political dialogue; and
- (5) security dialogue.

In addition, the EU will propose the establishment of a sixth specialised working group on environment and climate change at the first meeting of the Joint Committee pursuant to Article 14 (2) of the Committee's Rules of Procedure.

The aim of this proposal is to establish the EU's position in the Joint Committee on:

- (i) adopting the Joint Committee's rules of procedure; and
- (ii) setting up the specialised working groups.

The EU position will be based on the attached draft Decisions of the Joint Committee.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the functioning of the European Union, and in particular Articles 207, 209 and 218(9) thereof,

Having regard to the proposal from the Commission,

Whereas:

- (1) The Framework Agreement on Comprehensive Partnership and Cooperation between the European Community and its Member States, of the one part, and the Republic of Indonesia, of the other part ('the Agreement') entered into force on 1 May 2014.
- (2) Pursuant to Article 41 of the Agreement, a Joint Committee was established in order to ensure, *inter alia*, its proper functioning and implementation.
- (3) In order to contribute to the effective implementation of the Agreement, the rules of procedure of the Joint Committee should be adopted.
- (4) The Union's position in the Joint Committee as regards the adoption of the rules of procedure should be based on the attached draft Decisions of the Joint Committee,

HAS ADOPTED THIS DECISION:

Article 1

- 1. The position to be adopted by the Union in the Joint Committee set up under Article 41 of the Agreement, on:
 - adopting the Joint Committee's rules of procedure; and
 - setting up specialised working groups,

shall be based on the draft Decisions of the Joint Committee annexed to this Decision.

2. The Union's representatives in the Joint Committee may agree minor changes to the draft Decisions without referring back to the Council.

Article 2

This Decision shall enter into force on the date of its adoption. Done at Brussels,
