- BRUNEI DARUSSALAM, Partial withdrawal of reservations made in relation to the CONVENTION ON THE RIGHTS OF THE CHILD (1989) on 10 August 2015. Deadline for objections 9 August 2016.
- AZERBAIJAN, Declaration made upon ACCESSION to the CONVENTION ON MUTUAL ADMINISTRATIVE ASSISTANCE IN TAX MATTERS (1988) AND PROTOCOL AMENDING THE CONVENTION ON MUTUAL ADMINISTRATIVE ASSISTANCE IN TAX MATTERS (2010) on 5 June 2015. Deadline for objections 4 June 2016.
