The EU is funding numerous other important initiatives which contribute towards the improvement of efficient and comprehensive management of migration in partner countries. Such projects include:

- Support to the Africa-EU Migration and Mobility Dialogue (EUR 18.9 million/Pan-African Programme);
- Economic Security, WASH, Health and Protection activities in Syria (EUR 15 million/ Humanitarian aid);
- Regional Development and Protection Programmes North Africa (EUR 13 million/AMIF and ENI), Horn of Africa (EUR 125 million/EU Trust Fund for Africa and AMIF) and Middle East (EUR 12.3 million);
- Promoting Migrant Integration in Morocco (EUR 10 million/ENI);
- the Regional Support to Protection-Sensitive Migration Management in the Western Balkans (EUR 8 million/IPA);
- Euromed Migration IV in the Southern Neighbourhood region (EUR 7 million/ENI);
- Targeted initiatives to support the EU-Tunisia and EU-Morocco Mobility Partnerships (EUR 5 million each/GPGC):
- the Development of Protection Strategies for Persons in Need of International Protection in the Urban Context in Turkey (EUR 2.3 million/IPA).
