1. International Procurement Instrument – Amended proposal for a Regulation of the European Parliament and of the Council on the access of third-country goods and services to the Union’s internal market in public procurement and procedures supporting negotiations on access of Union goods and services to the public procurement markets of third countries.
2. TDI Modernisation – Proposal for a Regulation of the European Parliament and the Council amending Council Regulation (EC) No 1225/2009 on the protection against dumped imports from countries not members of the European Community and Council Regulation (EC) No 597/2009 on protection against subsidized imports from countries not members of the European Community.
3. Ecuador – Regulation of the European parliament and the Council amending Regulation (EU) No 19/2013 implementing the bilateral safeguard clause and the stabilisation mechanism for bananas of the Trade Agreement between the European Union and its Member States, of the one part, and Colombia and Peru, of the other part, and amending Regulation (EU) No 20/2013 implementing the bilateral safeguard clause and the stabilisation mechanism for bananas of the Agreement establishing an Association between the European Union and its Member States, on the one hand, and Central America on the other.
4. Conflict minerals - Proposal for a Regulation of the European Parliament and of the Council setting up a Union system for supply chain due diligence self-certification of responsible importers of tin, tantalum and tungsten, their ores, and gold originating in conflict-affected and high-risk areas.

- 5.1. Trade defense third country: investigation under the agricultural safeguard clause of the bilateral Agreement between the EU and South Africa (Agreement on Trade, Development and Cooperation between the EU and the Republic of South Africa, the TDCA).
