THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision of 22 July 2003 setting up an Advisory Committee on Safety and Health at Work¹, and in particular Article 3 thereof,

Having regard to the list of candidates submitted to the Council by the Governments of the Member States,

Whereas:

- By its Decisions of 24 February 2016², 11 Arpil 2016³ and 9 June 2016⁴ the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period from 29 February 2016 until 28 February 2019.
