<u>The Mixed Committee at Ministerial level</u> held a policy debate, following which the Chair concluded that the Council would subsequently be in a position to reach a general approach on the amended draft Directive set out in document 9841/16.

<u>Ministers</u> discussed the current migratory situation and in particular the implementation of the EU-Turkey Statement of 18 March 2016 and the migratory flows in the Central Mediterranean.

<u>Ministers</u> reaffirmed that returns to Turkey from Greece should be stepped up; for this, action was urgently needed in Greece. The EU's assistance, through Frontex and EASO, should also prioritise its contributions to these returns. Ministers supported the steps taken by the Greek authorities to address the issues of return to Turkey.

<u>Ministers</u> stressed that asylum and reception capacity must increase and living conditions must be improved.

<u>Participating States</u> were invited to speed up the resettlement of Syrian refugees from Turkey under the 1:1 scheme and prepare for the Voluntary Humanitarian Admission Scheme. They were also urged to accelerate the relocation of asylum seekers from Greece and Italy, in accordance with the Council decisions of September 2015.

<u>Ministers</u> held a general debate on visa liberalisation in the light of the recent proposals by the Commission related to Georgia, Ukraine, Kosovo* and Turkey.

The Presidency concluded that there was not yet enough support for the adoption of a mandate to start negotiations with the European Parliament on the proposal regarding visa liberalisation for Georgia. Several Member States expressed their dissatisfaction with this situation and their hope that a mandate would be approved as soon as possible. The four proposals that are currently on the table (namely Georgia, Ukraine, Kosovo* and Turkey) would be examined further in the following weeks in the relevant bodies of the Council. Ministers stressed that visa requirements could only be lifted when previously agreed benchmarks were fulfilled. Ministers also noted that the decision would be taken in a strict and fair manner on the basis of the assessment by the Commission as to whether the benchmarks had been fulfilled.
