### d) Detailed grounds for the transfer

According to article 9 of the Multiannual Financial Framework the Emergency Aid Reserve (EAR) is intended to allow for a rapid response to specific aid requirements of third countries following events which could not be foreseen when the budget was established; first and foremost for humanitarian operations, but also for civil crisis management and protection, and situations of particular pressure resulting from migratory flows at the Union's external borders, where circumstances so require.

#### d) Detailed grounds for the transfer

Turkey is hosting some 3.1 million Syrian refugees. Between 1 February and 15 March 2016, the number of out-of-camp Syrian refugees has increased by 162 346. The total of those living out-of-camp but under temporary protection is 2 747 946 (nearly 90% of the Syrians in Turkey).

Most of the support provided so far by the Turkish government (EUR 7 billion) goes for the camps hosting only 10% of the Syrian refugees. The Commission is therefore focusing on the more vulnerable who live with host communities and have so far received limited assistance.

Additional EUR 75 million is needed to help reach the total contribution from the Humanitarian aid to the Facility for Refugees in Turkey (FRT) (EUR 165 million in 2016). Part of that amount (EUR 20 million) will be covered from the Operational Reserve (OR) for Humanitarian aid.

As of 1 June, the overall implementation rate in commitment appropriations of the humanitarian aid chapter was at 89% (and 89% for the main line "Humanitarian aid and food assistance" 23 02 01). In payment appropriations it was at 49% for the humanitarian chapter and 48% for the main line. The balance in the OR for Humanitarian aid, after taking into account all pending requests, including EUR 20 million for FRT, will be at EUR 85 million. This amount is needed to cover crises and natural disasters until the end of the year.

The Commission has also considered possibilities for redeployment from other policy areas in Heading 4. However, at this stage of the year no such availabilities could be identified.

The Commission therefore presents a request for the mobilisation of the Emergency Aid Reserve in the amount of EUR 55 million in commitment and EUR 44 million in payment appropriations for the above mentioned crisis.

### When the funds are needed? June 2016

### Why additional funding is needed?

Since the beginning of the refugee crisis in 2015 the EU and the Turkish government have engaged in firm commitments to ensure that the needs of Syrian refugees under temporary protection in Turkey are met. The strategic focus of EU's humanitarian aid in 2016 is on the Syrian refugees in Turkey and it is fully aligned with the EU-Turkey Joint Action Plan (JAP) and ensuing political commitments at Heads of State level.

EU-Turkey Joint Action Plan of 15 October 2015 states:

"The EU side intends to:

2. ... continue, by way of close cooperation with the Turkish authorities, to provide immediate and principled humanitarian assistance via relevant humanitarian organisations in Turkey to address the most urgent humanitarian needs on the basis on their vulnerability in parallel and complementary to bilateral cooperation programmes aimed at addressing the needs created by the protracted refugee crisis."

The Facility for Refugees in Turkey (FRT) was established with Commission Decision of 24 November 2015 and amending decision of 10 February 2016 for 2016-2017. EUR 3 billion will be provided from the EU to improve the living conditions of refugees

in Turkey, while Turkey agreed to assist in stemming the flows of refugees to the EU.

The sources of financing will be: EUR 1 billion to be provided by the EU budget and EUR 2 billion by the Member States. The Steering Committee of the Facility agreed in principle that roughly EUR 1 billion would be disbursed for humanitarian assistance for 2016-2017 and the rest of longer-term interventions under other instruments (MADAD Trust Fund, IPA, IcSP, etc.).

Following current agreement, at least EUR 600 million will be required for Humanitarian aid in 2016 and EUR 400 million in 2017, including Member States' contributions. Consequently, HUMA's contribution to the FRT will amount to EUR 165 million in 2016, with the additional EUR 435 million to come from Member States.

So far EUR 90 million has been committed from HUMA 2016, including a previous mobilisation of the EAR for EUR 10 million. In order to meet the remaining funding requirement of EUR 75 million, the Commission proposes the mobilization of the EAR for EUR 55 million. An additional EUR 20 million will be used from the Humanitarian aid Operational Reserve.

# Additional needs

Turkey is host to some 3.1 million refugees. Between 1 February and 15 March 2016, the numbers of out-of-camp Syrian refugees have risen by 162 346 according to official Government figures (Ministry of Foreign Affairs). The total of those living out-of-camp but under temporary protection is 2 747 946. This represents nearly 90% of Syrians in Turkey. Approximately 10% of the Syrians are living in camps, or temporary protection centres. So far most of the support provided by the Turkish Government (EUR 7 billion) has been disbursed for Syrian refugees in camps. With assistance there deemed largely of high quality, the Commission is now focusing its attention on the more vulnerable, who live with host communities and who have so far received limited assistance.

# What will it be used for?

The first tranche of funds (EUR 90 million) allowed increasing the support to core humanitarian operations in Turkey. It prepared the ground for the future Emergency Social Safety Net (ESSN) by stepping up funding to the World Food Programme for the conceptualisation of the ESSN and consolidated the cash-based assistance and protection components of the Non-Governmental Organisations.

The additional funds will be geared towards the core component for humanitarian assistance such as protection, health, etc., education in emergencies and to roll-out the ESSN, using the most appropriate modality that of the multi-purpose cash transfers on a much larger scale.
